## TENDERING PROCESS

- A) Tenders are to be dropped in the Tender Box which is kept in the Vendor Complex near Admn. Bldg., BHEL, R.C.Puram, Hyderabad-32 from **03.10.2012 to 26.10.2012 up to 11.00 hrs.**
- B) Tenderer has to submit both technical & price bids in separate covers on or before **26.10.2012 at 11.00 hrs.**
- C) Tender opening date for Technical bid (Un priced) **26.10.2010 at 13.30 hrs**
- D) Price bid opening will be done after technical scrutiny and the date of opening will be informed by BHEL
- E) Tenders without the documentary proof of prequalification requirements will be rejected .
- F) In case of tender application and tender documents downloaded from web site, the tenderer shall pay cost of tender documents and EMD for the work which the agency is tendering separately by means of two separate DDs (in favour of BHEL, Hyderabad) one towards cost of tender documents and second towards EMD. Both DD's shall be enclosed along with the Technical bid. DD may be drawn towards cost of EMD upto last date of receipt of tenders.

### **Prequalification requirements:**

1. Contractor shall furnish and enclose copies of ESI Code, PF code, VAT registration number.
2. Tender bids without EMD, cost of tender document, as stipulated, are liable for rejection.
3. PAN No & Income Tax Assessment/ Declaration copy.
4. Valid contractor registration certificate from any Govt.sectors/ Latest contractor registration certificate from other BHEL sister units or BHEL R.C. Puram.

### **TERMS AND CONDITIONS:**

- 1) Contractor shall follow General Instructions as per annexure-II, and general terms and conditions /obligations of the contractors as per Annexure- III, Special conditions as per Annexure –IV, Guidelines and statutory payments for labour engaged as per Annexure V, Compliance statement as per Annexure-VI.
- 2) Man power engaged should have minimum basic qualifications and experience in similar kind of work

- 3) Work shall be started immediately after issue of letter of Intent .For any delay in commencing the work, penalty will be levied at 0.5% per week of the total contract value limited to a maximum of 10%.

- 6) Contractor shall provide two (2) pairs of uniform, helmet, shoes, goggles, and gloves, washing soap, summer cap ,dungaree cloth etc., other personal protective equipment wherever applicable to their labour.
- 7) Any statutory increase in the wages of the labour during the contract period has to be borne by the contractor only and BHEL will not pay any escalation in rates.
- 8) The contractor is wholly responsible for any loss of life or partial disability of any of their employees while on duty.
- 9) In case of occurrence of any accident/ injury of contractor's staff, BHEL will not pay any compensation while they are on duty and contractor has to take care of same as a statutory obligation.
- 10) BHEL reserves the right to reject any or all tenders in part or in full without assigning any reason.
- 11) Above mentioned work shall be executed in accordance with the general agreement conditions applicable to job works as per OMI-195 of BHEL. A copy of the same can be had from the undersigned.

### Schedule of Work

**Name of work :** Operations like cutting, shearing, painting, punching and dispatch of raw materials like rounds, sheets, pipes etc. in BHEL 11 preparatory shop.

1. As per the planning requirement, collection of material from holding Store/Yard for issue vouchers like Shop cards, DS cards, SMIVs and Indirect vouchers. Right materials shall be picked up by the contractor from storage yard. Contractor will bring the materials from storage yard to preparatory shop by himself. Crane will be provided by BHEL.
2. Maintenance, upkeep of holding stores, preservation of materials is in the scope of the contractor. Contractor to ensure storing the materials in the allocated places and/ or in respective bin locations.
3. Arrange punching of attestation marks (Specification, Heat No.GR number) on the materials for third party inspection.
4. Linking of the material cards/SMIVs with materials, subsequently handing over to their machine operator for cutting/shearing.
5. Perform cutting/shearing/deburring operation as per requirement.
6. After cutting, the jobs are to be kept in its specified racks shop wise (01, 02,06,51,07 (Tool Room) and 210 (Spares), etc).
7. On individual pieces, punching of specifications, heat no., and painting of
  - (a) Sale Order No., Work Order No., Part No., No. of pieces, etc., For DS items.
  - (b) SMIV No., vendors' name, No. of pieces and GR No., for SMIVs.
  - (c) Work Order No., Part No., No. of pieces, specification and Heat No. and Size, etc., for Shop items and for indirect vouchers.
 Wherever attestation is required, Specification and Heat No's are to be punched on the job i.e., cut pieces.
8. Assisting in preparation of Computerized Gate Passes.
9. Coordination with QC for clearance of materials.
10. Metallic boxes are to be used to transport the cut pieces and bring back the empty boxes from shop / CDC.
11. Return of left over / balance raw materials to holding Stores after cutting / shearing & placing them in respective locations.
12. Employ qualified and experienced operators who can co-relate materials with concerned documents in the Preparatory Shop.
13. Correct material / Specification to be cut as per Issue Vouchers.

  - a. Form XIII - Register of workmen employed by contractor (Rule 75).
  - b. Form XIV - Employment card issued by contractor (Rule 76).
  - c. Form XVI - Muster Roll (Rule 78 (1) (a) (i)).
  - d. Form XVII - Register of Wages (Rule 78 (1) (a) (i)).

- 4 The contractor shall maintain the above neatly, completely and legibly for inspection by various statutory authorities and the company officials even at short notice.
- The contractor shall observe
- (a) Weekly rest day.
- (b) The company list of holidays.
- 5 Contractor shall obtain complete bio-data of the labour, employment certificate and Antecedent verification in the prescribed form for each labour and supervisor engaged by him and shall submit the same to the Personnel Department / IR section through the contract executing officers before commencement of the work
- 6 The contractor shall ensure that entry and exit of labour shall be as per the procedure laid down by BHEL / HR dept
- 7 The Entry permits are to be issued to the Contract Labour by Assistant Commandant / CISF (Plant), based on the requisition submitted by Contractor through Executing Officer and forwarded by HR(IR) Executive.
- 8 Every contractor shall submit a notice regarding commencement and completion, of work in form – VI A&B [Rule 25 (VIII) & 81 (3)] to HR Department, IR section through his contract executing officer, for forwarding the same to State/Central Labour Department.
- 9 The contractor shall make himself or his representative available at the work spot everyday during execution of work, for effective supervision.
- 10 The contractor shall attend to all inspections notified / conducted by the HR Department, Labour Department, P.F. authorities. Factory Inspectors ESI Inspectors or any other such authorities under the act.
- 11 Non – compliance of any provisions under the act/ rule/instructions / guidelines shall make the contractor liable for penal action including termination of contract.

- 12 Contractor shall furnish in a separate letter his place of residence and postal address. The delivery at the above named place or posting in a Post box regularly maintained by the post and telegraph Department or sending letters registered for acknowledgement of any notice, letter or other communication to the contractor. Change in address shall come into force at any time by an instrument executed by the contractor and delivered to the Company official who has signed the contract.
- 13 The contractor must satisfy himself by personal study and examination of the drawings / specifications furnished and understands thoroughly the scope of proposed work in detail and all conditions affecting the work before entering into the contract. There shall not be at any time dispute / complaint of any misunderstanding with regard to scope of work and interpretation of specifications or any misunderstanding with regard to nature or omission of the work to be done not shall any application for compensation in terms of time and money shall be accepted by company regarding the above.
- 14 Contractor shall in his absence keep competent agent constantly on the works and any directions or explanations given by the “Contract Signing Officer” or his representative to such agent shall be held to have been given to the contractor himself.
- 15 Contractor on the advise of company official shall immediately remove any person employed by him, who may in the opinion of the company official is incompetent or misconducts himself and such persons shall not be again employed on the works without written permission of the company official.
- 16 The contractor shall erect and maintain at his own cost temporary weather proof sheds at such places approved by the company for keeping materials under cover if required.
- 17 The contractor shall give all notices required by the acts regulations, bylaws, legal acts and pay all fees in connection therewith unless and otherwise arranged and decided in writing with the company. He shall also ensure that no attachments are made against materials or work forming part of or for the use of the contractor. In all such cases, contractor shall protect and indemnify the company against any claim or liability arising from or based on the violation of any such laws, ordinances, regulations ,orders, decrees or attachments either by himself or by his employees,

- 18 It shall be contractor's sole responsibility to protect the public and his employees against accident from any cause and provide required safety equipments and shall indemnify the company against any claims for damages for injury to the person or property resulting from any such accidents and shall, where the provisions of the workmen's compensation act apply, take steps to properly insure against any claims there under.
- 19 In the event of any accident in respect of which compensation may become payable under the workmen's compensation act. VIII of 1923 whether by the contractor or by the company as principle employer, it shall be lawful for the company to retain out of amount due and payable to the contractor such sum or sums of money as may, in the opinion of the company shall be final in regard to all matter arising in this clause.
- 20 No work shall be done on Sundays or on other declared holidays of the company without the written permission of the company officer in charge of the work. The contractor shall comply with the provisions of the Factories Act Rules framed there under if the same are applicable.
- 21 The contractor shall keep his work place clean and safe to avoid injuries to men and damage to finished products / equipments.
- 22 On the occurrence of an accident, which results in the death of any of the workmen employed by the contractor or which is so serious as to be likely to result in the death of any such workmen, the contractor shall within 24 hours of the happening of such an accident intimate in writing to the company official in charge of the work.
- 23 The contractor shall indemnify the company against all losses or damages sustained by the company resulting directly or indirectly from his failure to give intimation in the manner aforesaid including the penalties or dues if any and become payable by the company, as a consequence of failure, the company to give notice under the workmen's compensation act or otherwise confirm to the provisions of the said act in regard to such accident.
- 24 The contractor shall ensure adherence to all statutory requirements under the State/Central rules in respect of service conditions for the employment of contract labour. The contractor shall get himself licensed from the State/Central Labour Commissioner as a contractor in accordance with AP contract Labour (R&A) rules, 1971. It is understood by the

contractor that for this agreement to be effective, the prime condition is his fulfilling the conditions of being licenced as a contractor under State/Central Legislation and continuance of this agreement is subject to the sustained ensurance of fulfillment to all statutory requirements including those contained in Labour Commissioner's notification No. D1/8385/79 in respect of employment conditions for contract labour, ESI Act and payment of wages as specified by State/Central Government from time to time. Further as and when there are changes in the service conditions/wages rates for contract labour, as notified by the State/Central Labour Department, the same will be implemented even if some modification is given at any time after the conclusion of the agreement. Any violation in respect of observance of statutory requirements under the contract labour (Regulation & Abolition) Act,1971 will make the agreement liable for immediate termination. Valid contract labour license shall be produced to BHEL for verification before entering into the contract.

- 25 The contractor shall abide by all the labour laws especially including contract labour (R & A ) Act, payment of wages Act, workmen's compensation act, minimum wages Act, ESI Act and Provident Fund Act as amended from time to time.
- 26 The contractor shall obtain a separate Provident Fund Code for his establishment and ensure implementation of provident Fund Act in the case of all eligible employees and in the process shall conform to all stipulated conditions under the Provident Fund Act and rules framed there under. Not withstanding the clause, in case of any financial loss incurred by the company on account of contravention of the Provident Fund regulations or any regulations of rule touching the same by the contractor, the contractor shall submit an undertaking to indemnify the company to the extent of the loss incurred by the company.
- 27 The contractor should engage only those labourers who shall be more than 18(eighteen) years of age.
- 28 The contractor shall not resort to sub-contracting under any circumstances. If found subcontracting at a later date, BHEL reserves the right to take whatever action it deems fit, including cancellation of the contract. The contractor shall not resort to subcontracting under any circumstances.
- 29 The contractor shall provide the required safety equipment to the labourers engaged by him.

- 30 Contractor shall issue “Employment Card” as per statutory requirement to all the labourers and supervisors covered under the job work contract.
- 31 The contractor shall be responsible to settle any grievances of the labour deployed by him.
- 32 A copy of the agreement between contractor and his labour shall be submitted to the personnel department.
- 33 ***Safety Measures:***
- (a) The Contractor shall provide the required safety equipment like uniform, safety belt, shoes, hand gloves, helmets etc., to the contract labourers engaged by him. All sorts of safety measures to be taken shall be deemed to form an integral part of the agreement and non-compliance with safety requirement amounts to breach of the contract.
- (b) Contractor has to obtain work permit for “ working at heights above 3 meters height from ground level ” wherever applicable .
- 34 Whenever the term “CONTRACTOR” is used, it shall be understood to refer to the particular person, firm or corporation with whom an agreement has been made by the concerned company official for executing the work defined in the concerned agreement and for the purpose of instructions regarding compliance with contract conditions, it shall include the contractor’s authorised representatives, who are entrusted with the work by contractor.
- 35 The quantities mentioned in the agreement schedule are worked out from the relevant drawings in the company and may not be the actuals required for execution.
- 36 The company does not expressly or by implication agree that the actual amount of the work to be done shall correspond there with, but reserves the right to increase or decrease the quantity of any class or portion of the work as he deems necessary.
- 37 All the works shall be carried out in accordance with the directions and to the satisfaction of the company official in accordance with the drawings, specifications and instructions. Supplementing or explaining the same as may from time to time shall be done by the company official.
- 38 For all modifications, omissions or additions to the approved drawings and specifications, the company shall issue revised plans or written instructions and no modifications, omission or addition shall be made unless so authorized and directed by the company in writing.

- 39 The company shall have the privilege of ordering modifications, omissions, or additions at any time before completion of the work.
- 40 All materials, articles, and workmanship shall be the best of their respective kinds for the class of work described in the contract specifications and schedule and materials to be obtained by the contractor shall be from sources approved by the company.
- 41 Sample of materials shall be furnished by the contractor at his expense to the company when called for before execution of any work.
- 42 The company shall have power to reject at any stage, any work which is considered to be defective in quality of materials or workmanship and shall not be debarred from rejecting wrong material by reasons of having previously passed them in an unworked condition. Any portion of the work or materials rejected or pronounced to be inferior or not in accordance with specifications shall be taken down and removed from the work site at the contractor's expenses.
- 43 The decision of the company shall be final and binding on the contractor on all technical questions which may arise in the contract with respect to material, workmanship, removal; of improper work, interpretation of the working drawings, specifications, notes, procedures etc.
- 44 The decision of the "Contract Signing Officer" or any officer deputed by him duly authorised on his behalf, in respect of the rate of progress and the quality of work or material shall be final.
- 45 Contracts shall be deemed to have included in his tender price of all appliances / equipments required for the purpose of all operations connected to secure a satisfactory quality of work within the opinion of the company will ensure the completion of the work within the time specified.
- 46 If at any time, during the progress of work or any part of it such methods or equipment appear to the company official to be insufficient or inappropriate for ensuring the quality of work required or rate of progress, he may order the contractor to increase their efficiency or to improve their quality of work and the contractor shall comply with such order and on failure of which the company may take such action as it deems it fit to improve the quality of work of the company may take such action as it deems if fit to improve the quality of work or the rate of progress required from the contractor and all such actions taken by the company shall be at the cost and risk of the contractor.

- 47 It is open to the company to lend or supply to the contractor any tools, implement, material and machinery that are needed by the contractor, which in the opinion of the company is essential to improve the quality or progress of work. The contractor shall pay such deposit or charges that may be fixed or determined by the company for any such articles or machinery lent or hired to the contractor.
- 48 Any electric power required for contractors machinery for the purpose of work shall be supplied by the company at the written request of the contractor at one point subject to the observance of rules and regulations of Electric board / company and charges there on shall be recovered from the contractor.
- 49 The contractor shall confirm to the regulations and laws of central / state govt. or any local authority and that of the company with whose system the machinery is supposed to be connected.
- 50 All rubbish as it accumulates shall be removed from the site to the point of disposal as indicated from time to time by the company. If this is not adhered to, the company shall remove the scrap and recover the cost of these operations from the bills of the contractor.
- 51 Any sum due from the contractor on account of tools and plants, stores, or any other items provided by the company shall be deducted from the respective bill due to him.
- 52 In case of breach of any of the terms and conditions of the contract, a claim shall be lodged under the bank guarantee with the guarantor at the discretion of the competent authority of the company. On successful completion of the contract to the satisfaction of the company, the bank guarantee shall be released after due claim period.
- 53 In the event of any question or dispute or under this contract, the same shall be referred to a competent Authority in the company for sole arbitration and his decision shall be final and binding on the parties to the contract.
- 54 In case of any suit or other legal proceeding arising under this contract, the courts at Sangareddy (Medak Dist.) A.P only shall have the Jurisdiction.
- 55 The company reserves the right to enter into parallel agreement with one or more contractor at their discretion.
- 56 Disputes, grievances between the contractor and his labour, will have to be settled by the contractor only.

- 57 The labour employed by the contractor, if found in abetting and fellow labour or contractors or any BHEL employee, the same shall be considered as an act of indiscipline. Such labourers shall be removed from the services of the contractor, on the advice of BHEL. Further the contractor shall initiate every necessary action in accordance with the relevant Laws, Rules & Regulations and enactments of State and Central Government.
- 58 Wherever, BHEL/COMPANY standards are mentioned, copies of which are enclosed shall be strictly followed.
- 59 Nothing contained in the contract agreement and its conditions shall be deemed to preclude or render inoperative the service of any notice, letter or other communication upon the contractor personally.
- 60 The decision of the “Contract Signing Officer” shall be final and binding on the contractor on all technical questions which may arise during the contract with respect to the quality of material, workmanship, removal of improper work, interpretation of the working drawings, specifications, notes, procedures etc.

SPECIAL CONDITIONS

1. Time is the essence of the contract and the specified time of completion is One years which will be reckoned from the date of commencement of work.
2. These special conditions supplement the conditions to tenders and contracts and the general conditions of contract and form part of the contract documents. Where these special conditions are at variance with the general conditions of contract these special conditions shall prevail.
3. All rates quoted shall be inclusive of all leads, lifts and other incidental charges and those in general conditions.
4. Before quoting his rates of the work, the tenderer shall inspect the site of work, nature, scope of work to be executed. BHEL will not however after acceptance of contracted rates, pay extra charges for any other reason. In case the contractor is found later on to have misjudged the nature and scope of work.
5. BHEL reserves the right to deviate either by addition or by deletion from the schedule of items of work given in the tender document after awarding the work.
6. In case of any difference between agreement wording and detailed drawings the interpretation of the contract executing official/ engineer shall be final and binding on the contractor.
7. Permissions for labour and materials shall be obtained in the prescribed formats.
8. The contractor must give a break of FIFTEEN DAYS for his workers on rotation without affecting the work after completion of every six months of contract period.

- iii) **Contractor shall provide two (2) pairs of uniform, helmet, shoes, goggles, and gloves, washing soap, summer cap ,dungaree cloth etc., other personal protective Equipments wherever applicable to their labour.**
- iv) Any increase in rate of DA/ Wages hike shall not be reimbursed to the contractor. The contractor shall anticipate such hike and quote in the tenders.
- v) Bonus @ 20% minimum or as per statutory requirement/Bonus Act 1965, which- ever is higher, will have to be paid to the workmen by the contractor.
