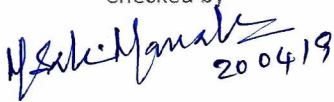
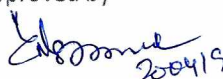
The Qualification requirements for Zero Liquid system (Crystallizer cum evaporator) are detailed below and Bidders should meet the same. Offers of bidders who do not meet qualification requirement will not be considered.

- a) The Bidder should have Designed, engineered, manufactured / supplied, erected and commissioned Crystallizer cum Evaporator system & Salt Centrifuge with Mechanical vapour Recompression system (Zero Liquid Discharge plant) of capacity not less than 3 m³/ hr.
- b) The bidder should have executed the above works combined or individually in any Power Plant/ Industrial Projects / Water supply Board/ Municipal Corporation in preceding Ten years reckoned from the last date for submission of bids to end Customer (KPCL) and the same shall be satisfactorily and demonstrably performed continuously for a minimum period of One year as on last date for submission of bids to end Customer (KPCL).
- c) The Bidder shall fulfill the minimum qualifying requirement as indicated in above para and the Proof of same shall be in the name of Bidder only.
- d) Bidder shall furnish the relevant satisfactory performance certificates. on letter head with Corporate Identification Number. signed by competent authority / CEO of respective Thermal Power Station / other major industries / water supply board etc. certifying the satisfactory performance of the equipment / system supplied and installed by the bidder in respect of paras above.
- e) The performance certificates mentioning continuous satisfactory performance shall be for a min of 1 Year within the latest period of 5 years only. (i.e. Should cover a minimum one-year successful running period between 2014 to 2019).
- f) Bidder should have in the last five years period i.e. 2013-14 to 2017-18 achieved in at least two financial years a minimum annual financial turnover of Rs. 56.00 Crore. As a proof, the bidders shall furnish Copies of audited P&L Account and audited balance sheet duly certified by a Chartered Accountant to establish annual turnover requirement along with PF registration (Independent PF code), Income tax, PAN No, GST /Service tax Registration certificate, Labour certificate.
- g) Bidder shall provide Undertaking in the form of a notarized affidavit declaring that during the past 3 years:
 - i. Their EMD has not been forfeited by KPCL.
 - ii. None of their contracts have been terminated/foreclosed on account of their default in KPCL or elsewhere.
 - iii. They have not been blacklisted/subject to procedure initiated for blacklisting for participation in tender issued by KPCL or government or any other utility in India and would not attract terms and conditions relating to rejection of bids.
