2. Please upload your best quotation/ offer on <https://eprocurebhel.co.in> for the requirement strictly as per schedule of price format (Annexure-F) before due date & time as mentioned in “PURCHASE ENQUIRY”.

Your best quotation/offer for the requirement mentioned in “PURCHASE ENQUIRY”, in line with our terms and conditions, should be submitted online via e-procurement system only. It shall be the responsibility of the bidder to ensure that the Tender is submitted on or before the due date Part-I bids shall be opened through e-procurement Portal. 3. **Procedure for Bid submission**: - Offer shall be submitted by the bidders in two parts: -

Part-I :- Technical cum Commercial bid

A- Part-I of the bid shall contain complete detail of the product offered. All Techno-Commercial terms & conditions and acceptance to the following: -

- (i) Duly signed & sealed copy of Annexure-A
- (ii) Duly signed & sealed copy of Annexure-B (ENQUIRY)
- (iii) Duly signed & sealed copy of Annexure-C (TECHNICAL SPECIFICATION)
- (iv) Duly signed & sealed copy of Annexure-D (PRE QUALIFYING REQUIREMENT)
- (v) Duly signed & sealed copy of Annexure-E (MANDATORY SHEET)
- (vi) Duly signed & sealed copy of Annexure-F (BLANK PRICE BID)
- (vii) Duly signed& sealed copy of Annexure-G (VENDOR LIST)
- (viii) Duly signed& sealed copy of Annexure-H (GENERAL TERMS & CONDITIONS OF ENQUIRY)

B- In case it becomes necessary to deviate in any of the above, the deviations must be clearly brought out in bid Part- I of the offer. Copy of un-priced bid with status “quoted (Q) & un-quoted (NQ)” must accompany bid Part-I.

Bidders to mandatorily put sign and seal on all documents before uploading at e-procurement site <https://eprocurebhel.co.in> .

Part-II:- Price bid

Bidders have to quote their rate in as per attached Price format only attached as Annexure-F. Price bid format are to be filled in e-procurement module using Class-III digital signature.

Both Part-I (**Technical cum Commercial bid**) & Part-II (**Price bid as per uploaded Price format**) of the offer shall be duly filled, sealed and signed copy to be uploaded by bidders at e-procurement site only.

NOTE: -

. Documents and Credential as per Technical & PQR, Techno Commercial Bids and Price Bids should be uploaded on the e-procurement portal.

. Bidders to ensure that Third party/customer issued Certificates being submitted as proof of PQR qualification should have verifiable details of documents/certificate issuing authority such as name & designation of issuing Authority and its organisation contact number and email Id etc. In case the same found not available, BHEL has right to reject such document from evaluation.

4. **Bid Opening:** - The 'Techno-Commercial' part of the bid i.e. Bid Part-I of the offers shall be opened on the due date of tender opening. Clarification, wherever required on this part, shall be obtained from the bidders for their evaluation. The Price bid Part-II of such vendors alone shall be opened whose techno-commercial bids are found acceptable. The date of 'Price bid Part-II' opening shall be intimated later on. Before price bid opening / RA (reverse auction) all formalities for registration has to be completed by the bidders as per new supplier link at www.bhel.com.

Alternatively: "BHEL shall be resorting to Reverse Auction (RA) (Guidelines as available on www.bhel.com) for this tender . RA shall be conducted among all the techno-commercially qualified bidders. Price bids of all techno-commercially qualified bidders shall be opened and same shall be considered as initial bids of bidders in RA. In case any bidder(s) do (es) not participate in online Reverse Auction, their sealed envelope price bid along with applicable loading, if any, shall be considered for ranking."

5. **Pre-Qualification Criteria:** - For Pre-qualification criteria, Refer Annexure –D.

6. Compliance to **Make in India** circular issued by Govt.

"For this procurement the local content to categorize a supplier as a Class-I local supplier/ Class-II local supplier / Non local supplier and purchase preference to Class-I local supplier is, as defined in public Procurement (Preference to Make in India) order 2017 dated 16.09.2020 issued by DPIIT. In case of subsequent orders issued by the

nodal ministry changing the definition of local content for the items of the NIT, the same shall be applicable even if issued after issue of this NIT, but before opening of Part-II bids against this NIT.”

This will supersede all other conditions attached in NIT.

7. Tenders shall be submitted strictly in accordance with the requirements of the above tender documents.
8. Standard pre-printed terms & conditions of the tenders may not be considered valid and offer may liable for rejection.
9. All the above tender documents shall automatically become a part of the Order/Contract after its finalization.
