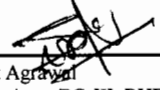

12. **Delivery Schedule:** - Six (06) months from the date of drgs. / docs. Approval in CAT-I (except Type test (if applicable) & O&M Manuals). Bidder to make 1st submission of all the drawings / documents as per drawing documents submission schedule (attached as per Annexure-I) and every re-submission of drawings / documents within 10 days of BHEL comments, if any. Conductance of Type test and Type test report approval shall be with in overall delivery period.
13. **Pre-Qualifying Requirements :**

Bids of only those bidders shall be evaluated who meet the Technical pre-qualifying requirements. Credentials of techno-commercially accepted bidders not listed in NTPC-NOA shall be submitted to NTPC for their acceptance.
14. Bidder to note that this is a conditional enquiry (Open Tender), the price bid (Part-II) opening / R.A. shall be subject to following criterion:

15. The bidder along with its associate / collaborators / sub-contractors / sub-vendors / consultants / service providers shall strictly adhere to BHEL Fraud prevention policy displayed on BHEL website <http://www.bhel.com> and shall immediately bring to the notice of BHEL management about any fraud or suspected fraud as soon as it comes to their notice.
16. Bidders have to quote freight charges in percentage of their quoted Total Ex- works prices.
17. BHEL reserves the right to go for Reverse Auction (R.A.) (Guidelines as available on www.bhel.com) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. Bidders to give their acceptance with the offer for participation in R.A. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for R.A.

Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit 'Process compliance form' (to the designated service provider) as well as 'Online sealed bid' in the Reverse Auction. Non-submission of 'Process compliance form' or 'Online sealed bid' by the agreed bidder(s) will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines for suspension of business dealings with suppliers/ contractors (as available on www.bhel.com).

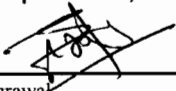
The bidders have to necessarily submit online sealed bid less than or equal to their envelope sealed price bid already submitted to BHEL along with the offer. The envelope sealed price bid of successful L1 bidder in R.A., if conducted, shall also be opened after R.A. and the order will be placed on lower of the two bids (R.A. closing price & envelope sealed price) thus obtained. The bidder having submitted this offer specifically agrees to this condition and undertakes to execute the contract on thus awarded rates.

If it is found that L1 bidder has quoted higher in online sealed bid in comparison to envelope sealed bid for any item(s), the bidder will be issued a warning letter to this effect. However, if the same bidder again defaults on this count in any subsequent tender in the unit, it will be considered as fraud and will invite action by BHEL as per extant guidelines for suspension of business dealings with suppliers/ contractors (as available on www.bhel.com)."

19. Bidders to quote their import content (CIF), if any in their price bid (Refer Annexure – CIF of Price Schedule). BHEL shall inform the availability of CIF value for the package including ceiling limit, if any, during commercial clarification/evaluation of offer.
20. If any bidder has mentioned the term **Not Applicable / Not required / Not Quoted** in BHEL price format, then the bidder needs to substantiate the same. If the same item will be required in future for the system same will be supplied free of cost.
21. BHEL reserves the right to finalize Prices by conducting Reverse Auction or by conventional way of price bid opening, which will be decided after techno-commercial evaluation. In view of above, bidders are requested to quote their most competitive prices as **no negative price impact** shall be applicable on account of non-conduction of RA.
22. All the above Tender Documents shall automatically become a part of the Order / Contract after its finalisation.
23. Evaluation shall be done separately on total F.O.R. cost to BHEL though **vendor shall have option to quote for any / both the categories:**

i. Oil Filled Service Transformers (Non ACC application-46 Nos.)

ii. Oil Filled Service Transformers (ACC application-45 Nos.)

Accordingly, separate purchase orders shall be placed.
