- (1) There is a change in the Tender Condition, Scope & Vehicle requirement as per the details given below:-
  - (a) From August 2011 to December 2011, We require 4 numbers of trailers daily with an average load of 100 MTs per Day. The Total quantum during this period of about 100 days is around 12500 MTs. Incase of daily load more than 100 MTs additional one number of trailer will be required from the same contractor for which intimation will be given 72 Hrs in advance.
  - (b) From January 2012 to May 2012, We require 8 numbers of trailers daily with an average load of 200 MTs per Day. The Total quantum during this period is around 30000 MTs. Incase of daily load of more than 200 MTs additional Two number of trailers will be required from the same contractors for which intimation will be given 72 Hrs in advance.
  - (c) Total Quantity 52500 MTs as given in Tender is only Indicative. Actual Quantity will vary depend upon the Production output. However, 25 MTs (average) per day per trailer is assured.
