SA335 P23: Si:0.25-0.50% and Cu::0.25 max

SA335 P92: Si:0.10-0.50%; Ni:0.30max and Cu:0.25max

3.0 **DIMENSIONAL TOLERANCES:** As per the specification.

For Outside Diameter(OD)controlled Pipes the tolerance on OD shall be: ±1% (Max: 4mm)of Nominal OD. For Inside Diameter (ID) controlled Pipes the tolerance shall be as indicated in the Purchase Order. Otherwise the tolerance shall be: On ID +0.0mm/-3.2mm. On thickness:+3.2mm / -0.0mm.

4.0 **HEAT TREATMENT:**

All the Pipes shall be Normalized and Tempered in the temperature as given below. The heat treatment temperature and the soaking time shall be reported in the test certificate.

Normalizing Temperature: 1050-1080°C

Tempering Temperature: 750°C-780°C. Soaking:1 Hour minimum. Still Air Cooling

(a)**Ultrasonic Testing:** Shall be conducted as per ASTM E213. Calibration:2 axial 50mm long notches (V or Square), one in outer surface and the other in inside surface. Notch depth: 5% of Nom. thickness. (min. of 0.3mm, max:1.5mm). Scanning: Clockwise & Anti clockwise.

7.0 STRAIGHTNESS:

The pipes shall not deviate from straightness by more than 1mm in any one meter, and shall not be more than 6mm over the entire length. A sharp bend at the end or kink and twist are not acceptable. These limitations are applicable for any given plane.

8.0 FINISH AND REPAIR

Inside and outside surface shall be free from imperfections and defects like laps, seams, folds, cracks, pitting etc Repairs by welding is prohibited Surface defects can be removed mechanically by grinding circumferentially without inducing any kind of depression and the depth of grinding shall not exceed 1.5mm.(not extending over a large area across the length and circumference of the pipe which affects the workmanlike finish), maintaining the specified minimum thickness without affecting the workmanlike finish. Loose scales shall be removed by blast cleaning in both inside and outside surface.
