TENDER TERMS AND CONDITIONS

I. PRE - QUALIFICATION CRITERIA:

1. Earnest Money Deposit (EMD)-Rs. 11,000/- (Rupees Eleven Thousand Only)
2. The contractor should have an Income Tax Registration (PAN). (Details of self- attested copy to be furnished)
3. The bidder could be a Proprietorship / Partnership firm / LLP / One-person company / Private Ltd company / Public Ltd company / Trust / Manufacturer / Dealer / Distributor/ Society in this line of service or business. Documentary proof/ Xerox copy shall be enclosed.
4. Goods and Service Tax (GST) Registration/Application Reference Number. (Copy of Registration details indicating GSTIN to be submitted along with offer. If any specific exemption is available, a declaration with due supporting documents need to be furnished for considering the offer).
5. Whether the Bidder is a manufacturer or distributor or dealer in this line of business. Documentary proof to be enclosed. If the Bidder is a Distributor / Dealer, then he shall obtain a certificate of Distributorship / Dealership from the original manufacturer.
6. The Bidder shall have Valid License/Certificate from BIS (Bureau of Indian Standards) as per IS 14543:2004 and copy of the same shall be submitted along with the Bid. In case the bidder is the Distributor /dealer, he will have to produce the BIS License/certificate for the manufacturer which should be valid throughout the contract period.
7. Recertification/Renewal of BIS license/Certificate to be completed before the expiry of the certificate/license.
8. On award of contract, the successful bidder shall comply with all the statutory requirements of PF and ESI rules & regulations and also other relevant statutory norms for their workmen deputed for this work.

NOTES: (1) Only those bidders, who are meeting all the above qualifying criteria, will be considered for further evaluation and others will be summarily rejected.

(2) The pre-Qualification Criteria details as per Annexure-A to be filled and submitted with supporting documents for BHEL reference and verification. Documents submitted with offer shall be signed & Stamped in each page by authorized representative of the bidder, without which bids will not be considered for further evaluation.

II. Scope of work:

1. The requirement of packaged drinking water -20 litres, 1 Litre and 300 Ml capacities are mentioned in table A.. The actual consumption quantity may be more or less, by upto 20 to 25%, than the indicated in Work Order quantity (Table A).

2. Packaged Drinking Water shall be UV treated, RO processed and Ozonised and shall conform to the Bureau of Indian Standards (IS 14543:2004 the latest applicable amendment). Manufacturing date should be within two days of the supply date and the manufacturing date should be printed on the top/cap of the cans. BHEL reserves the right to reject the supply, if it is found to be unacceptable. The decision of BHEL in this matter shall be final.
3. The packaged drinking water bottles - 20 litres (water can), 1 Litre and 300 Ml capacities shall be provided in properly sealed condition. Water cans with broken/tampered seal will not be allowed and will be summarily rejected.

4. The refill bottles shall be delivered to our Factory, PPPU, BHEL, Thirumayam at around 35 to 40 designated Water points located within a radius of about 750 meters. The supplier shall provide the Bubble-top Water Dispenser (bottom part) fitted with suitable tap at free of cost. These dispensers will be returned back to the supplier at the end of contract. The contractor shall replace these Bubble-top Water Dispensers due to normal wear & tear and intimation by BHEL HR/Administration official.
5. Both the Bubble-top Dispenser and the refill bottles of 20 Litres(water can) capacities, 1 litre bottles and 300 MI bottles shall be made up of food grade plastic.
6. The supplier shall deliver the refill bottles (20 Litres) and collect the empty refill bottles on daily basis and also on special request from BHEL. In this regard, the onus is on the vendor towards studying the consumption trend at each designated water points mentioned earlier and confirming any additional requirement for the next ensuing day with BHEL Administration on a daily basis. The delivery of refill bottles (20 Litres) should be done in the morning (between 09.00 AM to 11:30 AM). Other bottles 1 Litre and 300 MI shall also be supplied as and when required by BHEL.

III. PENALTY:

1. BHEL at its option will be entitled to purchase elsewhere at the risk and cost of the supplier either the whole of the goods or any part which the supplier has failed to deliver or dispatch within the time stipulated or if the same were not available i.e. in case any shortage of drinking water cans arises on any day for the reason(s) which are attributable to lapse on part of the vendor.
2. Such purchases will be made from the nearest available substitute. The vendor shall be liable for any loss which the Purchaser may sustain by reason of such risk purchases i.e. the cost including tax in excess of the rates fixed in the work order/Purchase order will be recovered from the Vendor.
3. In addition to the above recovery in case of non supply/short supply, a penalty will also be imposed on the vendor. The penalty amount will be calculated as per formula indicated below:

$$\text{Penalty amount (in Rs.)} = \text{UR} \times 63 \times \text{NS},$$

Where,

UR= Work Order/Service Purchase Order unit rate (UR) for 20 Litre Cans

NS= Number of days of Non supply/Short Supply (NS)

In addition to penalties, relevant GST on penalties will also be recovered from Contractor's Bill.

IV. SPECIFIC TERMS AND CONDITIONS OF WORK:

1. The supplier shall quote the rates per refill bottle of 20 litres capacity, 1 litre bottle and 300 MI bottles. The rates shall be all inclusive of packing, delivery and supply at the designated water points in BHEL Thirumayam factory. There shall be no extra claim over and above unit rate.
2. Packaged Drinking Water manufacturer shall submit BIS Certificate/License copy along with the quotation. The certificate/License should be valid during the contract period. In case the expiry of BIS License/certificate falls within the contract period, the contractor has to necessarily complete the recertification before the expiry i.e. the vendor should always be in possession of a valid BIS License/certificate during the contract period. Failing which, implies that the water supplied by vendor is not meeting the quality standards and will be considered unsafe for consumption. Any packaged water can supply without valid license will not be acceptable and the same will be treated as non-supply. BHEL reserves the right to impose penalty as specified in point no. 2 and 3 (Penalty Clause), or may also terminate the contract. The decision of BHEL in this regard will be final.

V. PAYMENT TO THE CONTRACTOR:

A. Payment Terms:

- a) The consolidated statements and Bills in triplicate shall be prepared by the Contractor after the completion of all the activities covered under scope of work of the previous month, during the first week of succeeding

month and submitted to User Department (HR Dept.). The payment will be made through RTGS / EFT to the contractor after the receipt of the error free bill. It is to be noted that it will take around ten days to process the bill at User Department and Accounts section after submission.

b) Invoice shall indicate W.O and W.O SI. No in all invoices for processing payment.

NOTE: Three copies of INVOICE with original signature to be submitted every month on completion of work.

VI. CONTRACT PERIOD:

1. The contract execution period is for **12 Months** from the date of commencement of work.
2. If required, BHEL reserves the right to extend this subject contract for a further period under same terms and conditions subject to mutual acceptance of both parties.
3. The contract may be terminated by BHEL due to violations or non-performance of the Contract conditions by giving one month's notice.

VII. GENERAL:

1. The contractor agrees to indemnify BHEL against all claims and losses arising as a liability under the Payment of Wages Act, Employees Provident Fund & Miscellaneous Provisions Act, Industrial Disputes Act, Employees State Insurance Act, Contract Labour (Regulation & Abolition) Act, Workmen's Compensation Act, Arbitration Act, Minimum Wages Act, Inter State Migration Act etc. or any civil or criminal law in force so far as they relate to security personnel employed by the contractor for the company.
2. The liability of any compensation for injury to their staff or others arising as a result of duties by the staff shall be that of the contractor.
3. Income Tax or any other statutory dues liable to be paid by the contractor shall be recovered from the bills of the contractor for which TDS certificate will be issued by BHEL.
4. With regard to the interpretation of the terms and conditions of this contract, the decision of the Head of the Unit / BHEL – PPPU Thirumayam shall be final.
5. Any addition/deletion on the scope of work and terms & conditions under this contract shall be implemented based on mutual discussions between the "company" and the "contractor".
6. Disputes or differences arising from this tender or in any manner connected therewith shall be subjected to the following disputes resolution mechanism:
 - i. Any dispute shall initially be referred to the designated Senior Management of the parties for amicable settlement. Parties shall nominate two persons each from their senior management within 10 days of a dispute arising.
 - ii. If no amicable settlement is arrived at within 30 days, then any party may refer the dispute to sole arbitrator to be nominated by Head of the BHEL Unit/Region/Division issuing the Contract. The place of arbitration shall be at Trichy. All arbitration proceedings shall be conducted in English in accordance with the provisions of the Arbitration and Conciliation Act, 1996.
 - iii. The arbitration award shall be final and binding upon the parties and each party will bear its own costs of arbitration and equally share the fees of the arbitral tribunal.
 - iv. All disputes shall be subject to the exclusive jurisdiction of the Courts at Pudukkottai.

VIII. COMMERCIAL TERMS & CONDITIONS:

01. RATE:

- b. The supplier shall quote the rates per refill bottle of 20 litres capacity, 1 Litre bottle and 300 ML bottles. The rates shall be inclusive of packing, delivery and supply at the designated water points (around 35to 40) in BHEL Thirumayam factory.
- c. GST Payment will be reimbursed as per statutory provisions, subject to production of proof of payment / remittances only.
- d. The rates quoted in the tender shall remain **valid** initially for a period of at least **"FOUR MONTHS"** from the date of opening of Price Bid. After successful award of contract, the rates shall be firm throughout the contract period.
- e. Should a tenderer find discrepancies or omissions in the drawings or any of the tender documents should be in doubts as to their meaning; he should at once address the authority inviting the tender for clarifications. Every endeavour is made to avoid any error which can materially affect the basis of the tender but the successful tenderer shall be taken upon himself to provide for the risk or any error which may be subsequently discovered and shall make no subsequent claim on account thereof.
- f. Contractor has to ensure that all statutory payment as per Minimum wages act/ Payment of Wages act etc. to be taken care of while quoting. No claim in respect to payment to workman will be entertained at a later stage. It will be responsibility of contractor to comply with statutory payments to workmen in this regard.
- g. **Before tendering, the tenderers are strongly advised to inspect the site of work and its environments and be well acquainted with the actual working and other relevant conditions, position of materials and labour under scope of work covered.**
- h. Conditional and late tenders, tenders containing prima-facie absurd rates and amounts, tenders which are incomplete or otherwise considered defective and tenders not in accordance with the tender conditions herein contained and the tenders not in original are liable to be rejected.
- i. Canvassing in any form w.r.t. tenders is strictly prohibited and the tenders submitted by contractors who resort to canvassing are liable for rejection.
- j. In the event of tender being submitted by the firm, the tender must be signed separately and legibly by each partner or member of the firm or in their absence, by the person holding the power of attorney on behalf of the firm concerned. In the later case, a copy of the power of attorney duly attested by a Gazetted Officer must accompany the tender.
- k. Earnest Money Deposit will be refunded to the unsuccessful tenderers within 15 days on finalization of the award of work. In the case of successful tender, the earnest Money Deposit will be retained as part of the Security Deposits for satisfactory completion of the work. If the bidder withdraws his offer after submission of tender or after acceptance of tender or fails to start the work, the EMD shall be forfeited.
- l. BHEL reserves the right to
- i) Cancel the tender at any stage.
- ii) Finalize the contract through Reverse Auction / Price Bid Opening.
- iii) Negotiate or refloat the tender opened if L1 price is not the lowest acceptable price to BHEL inter-alia other reasons.
- m. BHEL reserves the right to go for Reverse Auction (RA) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. All bidders have to give their acceptance for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.
- n. In case BHEL decides to go for Reverse Auction, only those bidders who have given their acceptance to participate in RA will be allowed to participate in the Reverse Auction. Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit "online sealed bid" in the Reverse Auction. Non-submission of "online sealed bid" by the bidder will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines in vogue.
- o. All payments from BHEL in view of the execution of the contract are liable for IT (TDS), GST, PF & Group Insurance and all other statutory provisions as applicable. Hence, bidders shall confirm that they have suitable mechanism for effective compliance to the same.
- p. In case BHEL be held liable for any loss, damage or compensation to third parties arising by the Contractor, such loss, damage or compensation shall be paid by the Contractor to BHEL together with the costs incurred by BHEL on any legal proceedings pertaining thereto.

- q. The Contractor is directly responsible for injuries / death of any person employed by him as well as to the third party occupants or other users arising due to accident or otherwise during the contractual period. At any point of time, BHEL will not be responsible for any loss / damage.
- r. GST and all other taxes shall be shown extra in the bid. Bharat Heavy Electricals Limited, Thirumayam will not entertain any claim what so ever in this respect after opening the tenders. Also GST Registration / GST application reference number have to be provided as applicable.

02. Taxes and Duties:

1. GST portion of invoice will be released only upon:
 - 1.1 Vendor declaring such invoice in his GSTR-1 and
 - 1.2 Receipt of goods and tax invoice by BHEL and
 - 1.3 Confirmation of payment of GST thereon by vendor on GSTN portal
 2. In case GST credit is delayed or denied to BHEL due to non /delayed receipt of goods/services and /or tax invoice or expiry of timeline prescribed in GST law for availing such ITC or any other reasons not attributable to BHEL, GST amount will be recovered from vendor along with interest levied or leviable on BHEL from payment due to vendors (bills, SD etc.) from BHEL.
 3. In case vendor delays declaring such invoice in his return and GST credit availed by BHEL is denied or reversed subsequently as per GST law, GST amount paid by BHEL towards such ITC reversal as per GST law will be recovered from vendor /contractor along with interest levied/leviable on BHEL from payment due to vendors such as running bills or Security deposit etc. from BHEL.
- Note: Three copies of GST rule compliant tax INVOICE with original signature to be submitted every month on completion of work.

03. RISK PURCHASE:

- I. In the event of any successful Tenderer's failure to fulfil any of the Tender / Contract Terms & Conditions / Obligations, explicitly expressed or implied, as per Tender / Contract, BHEL may entrust the job to alternate vendor and get it completed to meet the BHEL service requirements and additional expenditure if any including consequential cost shall be totally recovered from the contractor who failed to complete the job in line with the BHEL tender / contract.
- II. The decision of BHEL with regard to the actual losses / consequential expenditure incurred by BHEL shall be final and binding on the contractor.

Terms & Conditions of Reverse Auction (RA)

Against this enquiry for the subject item/ system with detailed scope of supply as per enquiry specifications, BHEL may resort to "REVERSE AUCTION PROCEDURE" i.e., ON LINE BIDDING (THROUGH A SERVICE PROVIDER). The philosophy followed for reverse auction shall be English Reverse (No ties).

1. For the proposed reverse auction, technically and commercially acceptable bidders only shall be eligible to participate.
2. Those bidders who have given their acceptance for Reverse Auction (quoted against this tender enquiry) will have to necessarily submit „online sealed bid“ in the Reverse Auction. Non-submission of “online sealed bid“ by the bidder for any of the eligible items for which techno-commercially qualified will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines in vogue.
3. BHEL will engage the services of a service provider who will provide all necessary training and assistance before commencement of on line bidding ON-LINE-BIDDING through internet, at NO extra cost to the Bidders.
4. In case of reverse auction, BHEL will inform the bidders the details of Service Provider to enable them to contact & get trained.
5. Business rules like event date, time, bid decrement, extension etc. also will be communicated through service provider for compliance.
6. Bidders have to fax the Compliance form before start of Reverse auction. Without this, the bidder will not be eligible to participate in the event.

7. In line with the NIT terms, BHEL will provide the calculation sheet (e.g., EXCEL sheet) which will help to arrive at "Total Cost to BHEL" like Packing & forwarding charges, Taxes and Duties, Freight charges, Insurance, GST for Services and loading factors (for non-compliance to BHEL standard Commercial terms & conditions) for each of the bidder to enable them to fill-in the price and keep it ready for keying in during the Auction.
8. Reverse auction will be conducted on scheduled date & time.
9. At the end of Reverse Auction event, the lowest bidder value will be known on auction portal. The lowest bidder has to fax/e-mail the duly signed and filled-in prescribed format for price breakup including that of line items, if required, as provided on case-to-case basis to Service provider within two working days of Auction without fail.
10. In case BHEL decides not to go for Reverse Auction procedure for this tender enquiry, the Price bids and price impacts, if any, already submitted and available with BHEL shall be opened as per BHEL's standard practice.
11. Bidders shall be required to read the "Terms and Conditions" section of the auctions site of Service provider, using the Login IDs and passwords given to them by the service provider before reverse auction event. Bidders should acquaint themselves of the "Business Rules of Reverse Auction", which will be communicated before the Reverse Auction.
12. If the Bidder or any of his representatives are found to be involved in Price manipulation/ cartel formation of any kind, directly or indirectly by communicating with other bidders, action as per extant BHEL guidelines, shall be initiated by BHEL and the results of the RA scrapped/ aborted.
13. The Bidder shall not divulge either his Bids or any other exclusive details of BHEL to any other party.
14. In case BHEL decides to go for reverse auction, the H1 bidder (whose quote is highest in online sealed bid) will not be allowed to participate in further RA process provided minimum three bidders are left after removal of H1 bidder.
15. In case of tie for H1 bid (Identical online sealed bids), 15 minutes' additional time shall be provided and all the participating bidders shall be informed by mail/ message on bidding screen to enable bidders submit revised online sealed bids so as to break the tie.

 - "The **Officer-in charge**" means, the Officer deputed by the Head of Dept. /Executing Dept., to supervise the work or part of the work.
 - "**Approved**" and "**Directed**" means, the approval or direction of Head of Unit/PPPU-THIRUMAYAM, or person deputed by him for the particular purposes.
 - BHARAT HEAVY ELECTRICALS LIMITED" (herein after referred to as BHEL) shall mean the Board of Directors, Chairman, Executive Director, General Manager or other Administrative Officer of the said Company including Executive/CONTRACTS/PPPU authorized to invite tenders and enter into contract for works on behalf of the Company.
 - The "**Contract sum**" means, the sum accepted or the sum calculated in accordance with the prices accepted in tender and / or the contract rates as payable to the contractor for the execution of the work during the currency of the contract.
 - A "**week**" means, Seven Days, without regard to the number of hours worked or not worked in any day in that week.
 - A "**day**" means, the day of 24 hours (TWENTY-FOUR) irrespective of the number of hours worked or not worked in that day.
 - A "**working day**" means, any day other than that prescribed by the NEGOTIABLE INSTRUMENTS ACT as being a Holiday, and consists of the number of hours of labour as commonly recognized by good employers in the trade in the district where the work is carried out or as laid down in the BHEL regulations.
- 02. HEADING TO THE CONTRACT CONDITIONS:** The heading to these conditions shall not affect the interpretations thereof.

09. GOODS & SERVICE TAX (GST) REGISTRATION & COMPLIANCE

For any such delay in availing of tax credit for reasons attributable to supplier (as mentioned above), interest (calculated @ SBI Base Rate + 6%) along with penalty if any will be deducted for the delayed period i.e. from the month of receipt till the month tax credit is availed, from the running bills. GST on penalty along with penalty amount will be recovered from your due bills/SD/EMD.

10. SECURITY DEPOSIT

- 3) Assigns, Transfers, Sub-lets or attempts to assign, transfer or sub-let any portion of the work without the prior written approval of the BHEL.*

- 4) Fails to carry out the work and unauthorized absence for more than 3 days.*
- 5) Whenever BHEL exercise the authority to cancel the contract under these conditions, BHEL may have the work done by any means at the Contractor's risks and expenses provided always that in the event of the cost of the work so done (as certified by EXECUTIVE/CONTRACTS/PPPU which is final and conclusive) being less than the contract cost, the advantage shall accrue to the BHEL and if the cost exceeds the money due to Contractor under the contract, the Contractor shall either pay the excess*

REMOTE TRANSACTIONS:** The Contractor shall agree to and comply with all such terms and conditions as BHEL may prescribe from time to time and shall confirm that all transactions effected by or through facilities for conducting remote transactions including the Internet, World Wide Web, electronic data interchange, call centers, teleservice operations (whether voice, video, data or combination thereof) or by means of electronic, computer, automated machines network or through other means of telecommunication established by BHEL shall constitute legally binding and valid transactions when done.
- 31. CHANGE IN CONSTITUTION OF FIRM:** Changes in constitution of firm whenever it is made after submission of application or during currency of the contract, the existing firm has to duly inform the proposed changes to contracting department of BHEL at the appropriate time before the changes in the constitution are made. In case the absence of any such information BHEL is not responsible for the consequences arising out of the absence or suppression of information and the issue / dispute arising out of these changes and the firm is responsible for settling the issue or dispute among themselves (Partners etc.) or with the bankers or with any third party.
