- 3. However, Micro and Small Enterprises (MSEs) are exempted from paying EMD & Tender document cost.
- 4. Techno-commercial offer cover shall contain all documents duly filled and signed by the tenderer in all the pages with documentary evidences for qualifying criteria such as experience, value of work executed in the similar nature of work etc. Any bid without proper documentary evidence for qualifying criteria shall not be considered for further evaluation.
- 5. The price bid cover shall contain price bid document duly filled in and signed by the tenderer in all the pages. The tenderer has to quote most competitive rates for all the items given in the Bill of Quantities in price bid.

The completed techno-commercial bid and price bid along with requisite **EMD** for this work shall reach the office of the undersigned on or before "Last Date for Submission of offer" as specified above. In case of offer submission by email above procedure shall not be applicable and all documents needs to be sent on email before due date and time.

The Techno-commercial offer will be opened on the same day at above specified time. In case of opening day falls on holiday or happened to be declared as a holiday the receipt and opening of the tender shall automatically fall on the same timing of the next working day. Special Conditions of Contract

- 1) TENDER for supply of 03 (three) nos of 3.0 MT capacity Diesel operated Fork Lifters along with operators and helpers for shifting of materials within BHEL Goindwal, Tarn Taran, on rental basis.
- 2) Diesel for the operation of forklift trucks will be supplied by BHEL at free of cost.
- 3) The Timing of the Shifts as operational at BHEL, IVP is as follows:
 - i) I-Shift: 06.00 AM to 02.30 PM
 - ii) II-Shift:02.00 PM to 10.30 PM
 - iii) General Shift: 09.00 AM to 05.30 PM
- 4) PERIOD OF CONTRACT: Two (02) years from the date of award of Work Order/LOI. However, the period of contract may be extended further on the basis of mutual acceptance with same rate and same Terms & Conditions.
- 5) Make of fork lifters shall not be of older than October 2015.
- 6) Fork lifters shall be provided at BHEL, Goindwal within 30 days of receipt of Work Order/LOI.
- 7) Month shall be considered of 26 working days for all calculations
- 8) The hourly rate basis shall be calculated as following:
 - a) Of 16 Hour lifter operation: by dividing the final rate of 16 Hr Forklift by 26*2*8.
 - b) Of 8 Hour lifter operation: by dividing the final rate of 8 Hr Forklift by 26*8.
- 9) The overtime payment for 16 Hour lifter operation to be operated on overtime/days else than working days shall be calculated by using 8) (a). For downtime deduction in 16 Hour lifter operation, same basis to be used.
- 10) The overtime payment for 8 Hour lifter operation to be operated on overtime/days else than working days shall be calculated by using 8) (b). For downtime deduction in 8 Hour lifter operation, Same basis to be used.
- 11) BHEL reserves the right to cancel the full or part quantity of the contract at any time without assigning any reason by giving one-month notice period.
- 12) The rates quoted should be FIRM throughout the period of the contract.
- 13) The engagement of Fork Lifters will be on all Working Days excluding Weekly offs and holidays declared by BHEL. If the Fork Lifter/s are engaged on weekly offs or on holidays extra payment will be made as per the corresponding rate mentioned in the schedule: refer 9) & 10).
- 14) The Fork Lifters can be used in any of the shifts as per requirement of the Work and Shift timings for Fork Lifters will be intimated separately as per requirement of the BHEL and may not be necessarily the shift timings being observed in BHEL.
- 15) The deployment area of fork lifters and shift timings for the fork lifters shall be decided purely on the need basis and by BHEL only.
- 16) The weekly off day for each fork lifter shall be decided by BHEL and need not be assumed as Sunday. Also the fork lifters to be deployed on overtime and extra shifts shall be decided by BHEL.

- 17) For engaging the fork lifter beyond the above duration, extra payment will be made on pro-rata basis only when loading and unloading or movement or any activity related to internal movement in progress.
- 18) Non availability of fork lifter due to repair/maintenance works or any other reason is not permissible. In case of non-availability of fork lifter, payment shall be deducted based on hourly rates.
- 19) BHEL reserves the right to cancel the tender if any circumstances arise so, without assigning Any reason by giving one-month notice period.
- 20) L1 Bidder shall be decided purely on the basis of lowest total monthly rate quoted amongst all successful bidders in the Techno-Commercial bid.
- 21) There will be no price variation on account of any increase in cost of any spares parts and maintenance needed during the tenure of the contract. The bidder is advised to inspect the running condition inside BHEL factory before quoting any rate.
- 22) The User Agency will certify the utilization of the Fork Lifters as per the contract to enable forward bills for payment to Accounts Department after verification.
- 23) The contractor's responsibility under this contract shall commence from the date of LOI or work order whichever is earlier.
- 24) The contractor should engage his operators and helpers in sufficient number as required for operations and equip himself/supervisor depending on the nature of the operations with any necessary personal protective equipment for the safety of the individual as applicable by statutory requirement such as factories act, motor vehicle act etc.
- 25) The contractor will have to work as per direction by user Department and during the shift hours the crew of vehicle shall remain near the vehicle or at office.
- 26) The work covered by this contract should be done under the contractor's direct supervision and should not be sub-contracted at any time.
- 27) Any damage to BHEL materials due to rough and faulty handling by the contractor's men will have to be compensated by the contractor to BHEL. Similarly, if any damage caused to BHEL equipment's / installation, property of third party in the course of work by the contractor's men, the cost of same shall be borne by the contractor. The extent of damage to be decided by BHEL
- 28) While transporting the loads it should be ensured by the contractor that loading and Stacking are proper as per safety standards established by BHEL, so as not to cause safety hazards/unsafe condition.
- 29) BHEL Security and Safety Regulations should be observed by the tenderers when their men/vehicles engaged in the work under this contract and the vehicle and man power used shall comply the statutory requirements.
- 30) The drivers/helpers engaged under this contract shall not be permitted to stay inside BHEL complex after completing their work. Accommodation for Operators/Helpers will be provided by contractor.

- 31) The work should be carried out as per instructions of supervisor concerned and prior permission should be obtained from the concerned BHEL's Supervisor and executing section before starting the work and report to the other supervisor after completion at unloading point.
- 32) All necessary personal protective equipment's such as shoes, gloves, helmet etc. considered adequate by the Officer in-charge/safety department shall be made available by the contractor for the use of persons.
- 33) The contractor shall take adequate steps to ensure proper use of equipment by those concerned.

 All safety equipment necessary for the work shall be arranged by the contractor at his cost.
- 34) Security and safety regulations of BHEL should be observed and learnt while in BHEL complex.
- 35) Ignorance of such regulations will not be accepted as an excuse.
- 36) Any notice, direction or instruction to be given under the Contract shall be in writing and delivered by hand, post, facsimile or email to the Contractor.
- 37) BHEL shall not be responsible for any consequences arising out of non-intimation of change of address and the contractor should update the address as and when there is a change.
- 38) The General and Special conditions of Contract are complementary to each other and where they are conflict, the decision of BHEL is final. The tender notice containing various instructions and conditions shall also form a part of the contract.
- 39) The quoted rates by bidders shall include the rent charges of Fork Lifter along with operator & helper, Extension forks, To & fro charges for transportation-and maintenance charges for 3 MT lifting capacity Fork Lifter and all the costs to be incurred by the contractor in the execution of the contract and shall be exclusive of all Taxes and duties.
- 40) BHEL reserves the right to increase or decrease the tendered quantity and split the tendered quantity among more than one tenderer and place orders accordingly in any proportion, based on commitment, requirement and supplier's capability in terms of delivery and quality.
- 41) BHEL reserves the right to negotiate or refloat the tender opened if L1 price is not the lowest acceptable price to them inter-alia.
- 42) In the event of awarding of work, the performance of the tenderer of contract, will be monitored for all categories of work and BHEL reserves the right to initiate suitable action including suspension/ closure/termination of the contract.
- 43) **PAYMENT OF BILLS:** No advance payment will be made. Bills shall be submitted for payment on monthly basis within 30 days after end of the month. Biils should be submitted in triplicate along with monthly attendance certifying the utilization of forklifts as per contract during the month. Original bills will be forwarded to finance for payment along with attendance copy from user department. The payment will be made on monthly basis within 30-45 days from the respective completed work month through NEFT /RTGS only after receipt of the complete bills.
- 44) For claiming extra hours, fraction hours less than 30 minutes will be ignored and more than 30 minutes will be treated on one hour.
- 45) Inspection of Forklifts can be done by BHEL representative at contractor work before dispatch to BHEL.

46) LIQUIDATED DAMAGES (LD) / PENALTY:

- a) If the contractor fails to deploy the vehicles as per terms & conditions of the order within the delivery schedule, a) LD shall be levied @ 0.5 % of the order value per week of delay or part thereof subject to a maximum of 10% of the full order value.
- b) In case of any change to the order value, the LD shall be @ 0.5 % of the revised order value per week of delay or part thereof subject to a maximum of 10% of the revised order value.
- 47) Penalty towards breakdown: For non-operation of forklifts for continuous 72 hours, Rs.1500/- per day per vehicle will be deducted from suppler bills. Apart from this penalty, if the contractor fails to operate the contract or comply with any of the contractual obligation for continuous 72 hours, BHEL reserves the right to get the same done at the contractor's risk and cost by engaging another agency.

Annexure - A

HSE Requirements to fulfilled by contractor before deployment at factory premises

- 1. Load test certificate by authorized Third party agency.
- 2. All original valid documents related to the forklift like **RC, Healthiness certificate, Insurance, Pollution Certificate etc**.
- 3. All original valid documents related to the forklift operator like <u>Valid Driving License</u>, updated medical fitness and eye test certificates (required to be provided every year).
- 4. Forklift should be maintained on regular basis. The **monthly maintenance report** needs to be submitted to Indenting department.
- 5. Forklift must have all front and backlights, seat belt & reverse horn and other safety accessories in working condition at all times for better operation and safety of people working around.
- 6. The tyres, brakes and other parts of the forklift need to be in good working condition.
- 7. Forklift operator to have copy of valid driving license and other documents at all the time and need to be produced on demand by competent authorities.
- 8. Forklift shall not be left unmanned in the running condition.
- 9. The forklift operator must not come at work place under inebriated condition at any point of time.
- 10. The forklift supplying agency shall be responsible to take all the precautions to ensure safety of the labors / workers at work. Besides, as per rules all required safety accessories need to be provided. Any damage caused to BHEL property or any human life after BHEL certification shall be recovered from the running bills of the agency.
- 11. In case of non-compliance to above mentioned HSE requirements, BHEL reserves the right to take punitive action by withholding a sum of up to Rs.500/- for each violation. BHEL Security and Safety Regulations should be observed by the tenderers when their men / vehicles engaged in the work under this contract and the vehicle and manpower used shall comply the statutory requirements" .(penalty clause)
- 12. BHEL Security and Safety Regulations should be observed by the tenderers when their men / vehicles engaged in the work under this contract and the vehicle and manpower used shall comply the statutory requirements".

GENERAL INSTRUCTIONS TO BIDDER

- The Contractors who wish to participate should go through the Tender documents thoroughly and plan well before quoting, to ensure that the Tender process is not aborted / vitiated, due to their reasons.
- 2) Before Tendering the tenderers are advised to inspect the site of work and its environments and be well acquainted with the actual working and other relevant conditions, position of materials and labor. Tenderers are also requested to go through General -Terms & conditions, Special -Terms & conditions of Contract, Scope of work, Technical Terms & Conditions, drawings and specifications and all other documents which form part of the agreement to be entered into.
- 3) While quoting the rate, the tenderer is advised to take into account the likely expenditure, taxes what so ever, etc., excluding GST during the operation of the Contract period from the date of commencement of work as directed by BHEL.
- 4) While quoting the rates the tenderer is advised to take into account all factors including any fluctuations in market rates. No claim will be entertained on this account after acceptance of the tender or during the currency of the contract. All entries in Tender documents shall be clearly written in one ink or typed. All the corrections / cancellations / insertions, if any, shall be duly attested by the Bidders concerned.
- 5) Rates should be quoted as per the Price Bid. Rates quoted in any other form will not be accepted and will be rejected:
- 6) If, in the price structure quoted for the required goods / services / works, there is discrepancy between the unit price and the total price (which is obtained by multiplying the unit price by the quantity), the unit price shall prevail and the total price corrected accordingly, unless in the opinion of the purchaser there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price corrected accordingly.
- 7) If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected.
- 8) If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject to point 6 and 7 above.
- 9) If there is such discrepancy in an offer, the same shall be conveyed to the bidder with target date up to which the bidder has to send his acceptance on the above lines and if the bidder does not agree to the decision of the purchaser, the bid is liable to be ignored.
- **10)** The Bidder shall fill in all the required particulars of the Tender documents and also sign on each and every page of the Tender documents (Techno- Commercial Bid, Price Bids, Terms & Conditions etc.) including corrigendum & the drawing attached there to while submitting their tender.
- 11) Should a Bidder find discrepancies or omissions in the Tender documents or should there any doubt as to their meaning, he should at once address the authority inviting the Tender, for clarification well before the due date, so as to submit his Tender in time.
- 12) Every endeavor is made to avoid any error which can materially affect the basis of the tender but the successful tenderer shall take upon himself to provide for the risk or any error which may be subsequently discovered and shall make no subsequent claim on account thereof. (No extension of time shall be given for submission of the Tender on any account)
- 13) Conditional and late Tenders, Tenders containing prima-facie absurd rates and amounts, Tenders which are incomplete or otherwise considered defective and Tenders not in accordance with the Tender conditions herein contained and the Tenders not in original ARE LIABLE TO BE REJECTED
- **14)** If a Bidder deliberately gives wrong information in his Tender or creates conditions favorable for the acceptance of his Tender, BHEL WILL REJECT SUCH TENDER AT ANY STAGE.
- **15)** Words imparting singular number shall be deemed to include plural number and vice-versa where the context so requires.

- 16) Canvassing in any form, in connection with the Tender is strictly prohibited and such Tenders are bound to be rejected. All information furnished is taken to be authentic by the bidder for evaluation of Tender priorities. Should any information found to be incorrect subsequently, at any later time, the Tender / Contract shall be rejected / terminated and the / SD shall be forfeited.
- 17) Should a Bidder's or a Contractor's or in the case of a firm or company of Contractors / any of its shareholder's or shareholder's relative is employed in BHEL, the authority inviting the Tenders shall be informed in writing of this fact at the time of submission of the Tender, failing which the Tender may be disqualified, or if such fact subsequently comes to light, the Contract may be cancelled.
- **18)** Submission of Tenders by electronic media like e-mail, Internet, fax etc. is acceptable and will be at the sole risk of the Tenderer. Tenders can be sent to *tenderwcm-ivp@bhel.in*. Tenders thus submitted will be final and binding on the Tenderer. BHEL will not be responsible for any consequences that may arise in this regard.
- **19)** Late and Delayed Tenders will be summarily rejected and under no circumstances it will be considered and accepted. In case you are not in a position to submit the offer, please send letter suitably specifying the reasons thereof.
- 20) Price bid should not be enclosed along with the techno commercial bid and other documents in the same cover/envelope. The price bids have to be given category wise in a sealed cover and the entire lot of price bid sealed covers will have to be kept in a separate large cover, duly sealed. Bid should be free from correction, overwriting, using corrective fluid etc. Any interlineation, cutting, erasure or overwriting shall be valid if they are attested under full signature(s) of person(s) signing the bid else bid shall be liable for rejection.
- **21)** All overwriting/ cutting etc. will be numbered by bid opening officials and announced during bid opening.

22) Signing the Tender

- a) All the required documents shall be filled in the same serial order as per the format / column of the "techno-commercial bid". All the pages shall be serially numbered on the right hand side top corner. Page numbers of the concerned documents also shall be filled in "techno-commercial bid" in the boxes provided. All the pages of tender documents are to be duly signed and stamped by the bidder.
- b) The Tender shall be signed by the Authorized Signatory Only. Authorized signatory shall be the person holding 'power of attorney' on behalf of the firm / company / bidder-concerned authorized / empowered to act on behalf for the specific purpose
- c) Authorized signatory should have Power of Autonomy issued by MD or Board of Directors or authorized person for this purpose for quoting Tender and all procedures connected with, till finalization and execution of the Contract.
- d) In case the Bidder is a Partnership Firm under Partnership Act, the Tender shall be signed by all the Partners of the firm or by the Managing Partner who have Signature and Seal of the Contractor authorized to do so or by a person holding the Power of Attorney on behalf of the Partnership Firm.
- e) A copy of the Partnership Deed and / or a copy of the Power of Attorney, Self-attested shall accompany the Proprietor or Partner of the Company.
- f) BHEL will not be bound by any other Power of Attorney granted or the change in the composition of the firm made, subsequent to the execution of the Contract agreement. They may however recognize such Power of Attorney or change in status after obtaining legal advice and the cost involved in that connection shall be chargeable to the bidder concerned.

23) Address for sending the offer:

a) The offer should be sent to address as mentioned in Tender Notice well in advance so that it reaches before or on due date and time through registered post or in person.

24) Date / Time for opening of Tender

- a) Sealed covers so received will be opened at BHEL IVP Goindwal 143422 on the same day of due date of tender submission as per NIT (Notice inviting Tender) in the presence of the Bidders or their Authorized Representatives who may choose to witness the same.
- b) BHEL reserves the right to extend the due date of opening, which shall be informed. Validity of offer shall be deemed to be revised accordingly.
- c) The Techno Commercial bids only will be opened.
- d) The Price BIDS of bidders, who are technically qualified will be opened later. The date & time of price bid opening will be informed to the technically qualified Bidders.

25) Witnessing the Tender opening

- a) The Bidder or his authorized representative may choose to witness the Tender opening.
- b) Only one representative from one bidder will be allowed to participate in the Tender opening.

26) Quoting

a) Quoting the lowest best rate is a must against this Tender. However, bidders are required to understand that the lowest rate offered by them or accepted by them, as the case may be, should be honored throughout the period of the Contract.

27) Participation

a) The Parties who have been suspended or black listed or issued with "Show Cause Notice" by BHEL IVP Goindwal or any other BHEL Unit will not be allowed to participate in **the Tender** and the bidder should declare the same in the Tender. Even during the course of evaluation / finalization of Tender if it is found that some of the parties are black listed / barred from business transactions / under business hold, BHEL will not consider them for further participation in the Tender.

28) Validity of Offers:

- a) The rates quoted shall be valid for acceptance for a minimum period of 90 days from the date of Price Bid opening. Withdrawal of Tender or increasing the rates during this validity period is not allowed.
- b) BHEL reserves the right to accept or reject any part or whole of the tender of a bidder by assigning a valid reason thereof. BHEL reserves the right to cancel the tender without assigning any reason thereof and without any obligation before any commitment.
- **29)** If possible, please submit soft copy of price quotation [copied on a blank CD of standard make] put in the sealed offer.
- **30)** After releasing WO, it is assumed that supplier has accepted WO if we do not receive acknowledgement/declination from supplier within 10 days of date of WO.

GENERAL CONDITIONS OF CONTRACT (GCC)

- 1) **DEFINITION:** In these General Conditions of Contract, the following terms shall have the meaning hereby assigned to them, except where the context otherwise requires:
 - a) "Contract" means, the documents forming the Tender and acceptance thereof, together with all the documents referred to therein including general and special conditions to Contract. All these documents as applicable taken together shall be deemed to form one Contract and shall be complementary to one another. "Work" means, the work described in the Tender documents in individual work-orders as may be issued from time to time to the Contractor by the Officer-Incharge within the power conferred upon him including all notified or additional items of works and obligations to be carried out as required for the performance of Contract.
 - b) "Contractor" means, the individual Firm or Company whether incorporated or not, undertaking the work and shall include the legal personal representatives of such individuals or the persons composing the firm or Company or the successors of the firm or company and the permitted assigns of such individual or firm or Company.
 - c) "Officer-In charge" means, the Officer deputed by BHEL, IVP Goindwal, to supervise the work or part of the work.
 - d) "Approved" and "Directed" means, the approval or direction of BHEL, IVP Goindwal official, or person deputed by him for the particular purposes.

17) RISK PURCHASE

20) RIGHTS

- c) All amounts including the losses / damages / penalties / compensations etc., resulting from non-compliance with the terms of Contract, payable by the Contractor to BHEL under the Terms of the Contract will be recovered from the outstanding payments to Contractor either under this Contract or any other Contracts or from Security Deposit or from both. In case this amount is insufficient for such recoveries, the Contractor shall make good the balance amount by actual payment. - 24) PUBLIC PROCUREMENT POLICY: For this procurement, Public Procurement (Preference to Make in India), Order 2017 dated 15.06.2017 & 28.05.2018 and subsequent Orders issued by the respective Nodal Ministry shall be applicable even if issued after issue of this NIT but before finalization of contract/PO/WO against this NIT.
- 25) CANCELLATION OF CONTRACT FOR CORRUPT ACTS: -

- 34) FORCE MAJEURE: If at any time during the continuance of the contract, the performance in which or in any part by either party of any obligations under the contract are prevented or delayed by reason of any war, hostilities, acts of public enemy, civil commotion, sabotage, fires, explosions, epidemics, quarantine restrictions, or acts of God (hereinafter referred to "an events" then provided the notice of happening of any such event is given by either party to the other within 21 days of the occurrence thereof, neither party shall by reason of such event be entitled to terminate the contract nor shall either party have any claim for damages against the other in respect of such non-performance and delay in performance and delivery under the contract shall be resumed as soon as practicable after such event has come to an end or ceased to exist. If the performance in whole or part of any obligation under the contract is prevented or delayed by reason of any such event, claims of extension of time shall be granted for periods considered reasonable by BHEL subject to prior notification by the vendor to BHEL of the particulars of the event and supply to BHEL, if required, of any supporting evidence. Any waiver of time in respect of partial installment shall not be deemed a waiver of time in respect of remaining deliveries.
- **35) DISPUTES:** In the event of any dispute and/or difference arising between the Vendor and BHEL as to interpretation and/or execution of the contract and/or the respective rights and liabilities of the parties, such disputes and/or differences shall be referred to the sole arbitrator nominated by BHEL. The provisions of the Indian Arbitration Act and the rules there under shall apply to such arbitration. The award passed by the arbitrator shall be final and conclusively binding on all the parties.
- **36) JURISDICTION:** The court of the place from where the work order is issued during the contractual period shall alone have jurisdiction to decide any dispute arising out of or in connection with the purchase order.
- 37) CLARIFICATIONS: The correspondence exchanged against the tender from both tenderer and BHEL through email/e-procurement are considered as valid document legally though it is not signed. It is treated as valid confirmations made on behalf of the respective company and very much comes under the legal ambit of the business transaction and hence it is binding on both the parties to the business. Any transaction pertaining to the tender from both the parties of business done round the clock irrespective of the office or business hours of the companies, are valid legally and binding on both the parties. This applies to the extent only in such cases where deadline time for transaction is not specifically declared by either or both the parties to the business.
- **38) BANNED FIRMS:** The offers of the bidders who are on the banned list as also the offer of the bidders, who engage in the services of the banned firms, shall be rejected. The list of banned firms is available on BHEL website www.bhel.com.
- **39) DISCLAIMER CLAUSE (Only for E procurement):** Neither the Organization (Bharat Heavy Electricals Ltd.) nor the service provider (Mjunction Services Ltd.) is responsible for any failure of submission of bids due to failure of internet or other connectivity problems or reasons thereof.
- 40) FRAUD PREVENTION POLICY: The Bidder along with its associate / collaborators / sub-contractors / sub-vendors / consultants / service providers shall strictly adhere to BHEL Fraud Prevention Policy displayed on BHEL website http://www.bhel.com and shall immediately bring to the notice of BHEL management about any fraud or suspected fraud as soon as it comes to their notice.

41) REVERSE AUCTION

a) BHEL reserves the right to go for Reverse Auction (RA) (Guidelines as available on www.bhel.com) instead of opening the sealed envelope price bid, submitted by the bidder.

Pre-Qualification Terms

- 1. Vendor shall have PAN. Copy of PAN Card shall be submitted.
- 2. Bidder must not be under Bankruptcy Code Proceedings (IBC) by NCLT or under Liquidation/BIFR, Which will render him ineligible for participation in this tender. Bidder shall submit undertaking to this effect.
- 3. For Start-Up Firms: The PQR terms 1 & 2 will be applicable on Startup firms. However, BHEL reserves the right to provide the relaxations and exemptions in other tender terms to the startup firms in line with D.O. No. 5(4)/2016-BE-I dated 15.02.2017 & Office Memorandum issued by DPE vide F. No. DPE/7(04)/2007-Fin dated 24.08.2017 forwarding the clarification issued by Department of Expenditure, Ministry of Finance vide No. F.20-2/2014-PPD(Pt.) dated 27.07.2017 and DO letter vide D.O. No. 12(11)/2017-SI by Secretary DIPP, Ministry of Commerce and Industry. For claiming Start-Up exemption, bidder has to submit DPIIT (Dept. of Promotion of Industry and Internal Trade)/DIPP (Department for Industrial Policy and Promotion) recognition certificates. For Claiming MSE benefits, vendor have to give documentary evidence like NSIC, UAN, etc.

<u>Payment Terms:</u> No advance payment will be made. Bills shall be submitted for payment on monthly basis within 30 days after end of the month.
