

PART A

Instruction to Bidders:

1. Bidder shall quote lump sum price for the total works which includes Design, Engineering, Procurement, Construction and Commissioning as detailed in relevant chapters of Volume IA Technical Conditions of Contract.
2. In case the Bidder submits offer along with a Civil Consultant, the bidder(s) shall also indicate the percentage break-up of the lump sum price between the works of (i) Design and Engineering and (ii) Procurement, Construction, and Commissioning.

The percentage break-up for (i) Design and Engineering shall not exceed 10% of the total lump sum price. If the percentage indicated by the bidder for (i) Design and Engineering is greater than 10%, the same shall be considered as 10% only. If left blank, the same shall be considered as 0%.

3. Bidders shall only quote 'Total Amount' and 'Percentage considered for Design and Engineering' in the respective format given in this price bid. Any other entry elsewhere in the price bid shall be treated as Null and Void.

Quoting of rates in any other form/ formats will not be entertained.

Bidders to quote 'Total Amount' in the format given, which shall be taken into account for evaluation and awarding and hence, shall be complete in all respect for the full scope defined in specification and in accordance with all terms & conditions of tender.
