E-Tenders are invited in Two Part Bid System for entering into a Frame Work Agreement (Rate Contract) for Supply of Wooden Boxes as per BHEL drawing of respective Requisition mail/letter valid for one year from MSE suppliers only.

#### (I) General:

1. The tender will be under Two-part bid system i.e PQR cum Techno commercial bid and Price bid. Price bid shall be opened to those bidders who will qualify in PQR cum Techno-commercial evaluation.

3	The projected requirement shall be given in the tender. Vendor should state their capacity to supply the BHEL, per month. Vendor should have capacity to manufacture and supply (as per specifications attached at Annexure-) at least 300 boxes per month to BHEL FSIP Jagdishpur. Vendor's capacity to supply per month implies vendor's ability to supply such quantities of items meeting the quality requirements and delivery schedules. Vendors shall intimate only such capacity that can be allocated to BHEL FSIP Jagdishpur and not their total capacity. The vendors having capacity less than 300 Boxes per month will not be eligible as per technical criteria mentioned above. - 6. This tender is for Rate contract (Frame Work Agreement) and shall be valid for one year from date of finalization of tender. BHEL shall intimate by requisition letter/mail within validity of rate contract for supply of Wooden Boxes.

- 8. Rate shall be firm and there is no any price variation clause.
- 9. Supplier has to quote prices in Rs per Cubic Meter.
- 10. Please note that BHEL shall intimate by requisition letter/mail in numbers after calculating the rate by multiplying the drawing cubic meter volume of boxes with finalized rate (Rs/cubic meter) against Rate Contract finalized PO. BHEL may release requisition letter/mail of smaller quantity e.g 11, Nos, 30 Nos, 20 Nos etc. Bidders should quote their rates by considering the above facts.
