Payment for daily wage and leave / holiday payment with up-to-date cumulative figure should be recorded in payment register. Proof of payment of PF & ESI has to be enclosed along with monthly bill.
5	The contract labour may be allowed weekly off on any day other than sunday also, depending upon exigencies of work / BHEL requirement .
6	Service Tax, wherever claimed, is to be supported by Service Tax Invoice along with proof of payment of service tax for preceeding Service Tax invoice claimed from BHEL under this contract.
7	In case of tie in Price Bid and equal distribution of quantity is not feasible, contract can be awarded based on lottery.
