Following points relevant to the tender may please be noted and complied with:

Price shall not be mentioned by them anywhere in the techno-commercial portion of offer, it shall be mentioned in the relevant price schedule (Volume-III) only and submitted in separate sealed envelope. In case of any clarification, bidder may contact this office. Techno-commercial bid and Price-bid shall be put in separate sealed envelopes. Techno-commercial bid" and "Price-bid" should be clearly written on the respective envelope for easy identification. Now both these sealed envelopes shall be put in another envelope and the same be sealed and sent to as per point#3.
- 3.0** The offers shall be sent as per following details in separate sealed envelopes. Complete set of offer shall be sent to the office of General Manager, BHEL, 2x660MW STPP, Rampal, Dist-Bagerhat .
- 4.0** Your offer & documents submitted with the offer shall be signed & stamped in each page by your authorised representative. No overwriting/ correction in tender documents by bidders shall be allowed. However, if correction is unavoidable, the same may be signed by authorized signatory.
- 5.0** All documents/ annexures submitted with the offer shall be properly annexed and placed in respective places of the offer as per enclosure list mentioned in the covering letter. BHEL shall not be responsible for any missing documents.
- 6.0** No Deviation with respect to tender clauses and no additional clauses/ suggestions/ clarification in Techno-commercial bid/ Price bid shall normally be considered by BHEL. Bidders are requested to positively comply with the same. Offers with deviation are liable for rejection.
- 7.0** BHEL reserves the right to accept or reject any or all offer without assigning any reasons thereof. BHEL also reserve the right to cancel the tender wholly or partly without assigning any reason thereof.
- 8.0** Since the job shall be executed at site, bidders must visit site/ work area and study the job content, facilities available, prevailing site conditions including law & order situation etc. before quoting for this tender. They may also consult this office before submitting their offers, for any clarifications regarding scope of work, facilities available at sites or on terms and conditions. No additional claim shall be entertained by BHEL in future, on account of non-acquaintance of above.
