Technical Bid

A	Scope of Work :
1	The work involves conducting an NABET/IRCA accredited 5-days lead auditor course for EHS [integrated course on EMS as per latest version of ISO 14001 and OHS-MS based on BS OHSAS 18001].
2	The course shall be of 5-days (40 hours) duration.
3	Besides the basic understanding of IS/ISO 14001 the course shall also cover an overview and understanding of IS/ISO 14004.
4	The course shall be accredited and in line with the requirements of IS/ISO 14001, BS OHSAS 18001 and IS/ISO 19011.
5	All participants shall be provided with the copies of the training materials, exercises, case studies and auditing exercises. One extra copy of each document shall be provided for the organizers, i.e. BHEL's HSE department.
6	Necessary facilities like venue for the Training, Computer/Lap top, LCD projector and other logistics such as marker pens, photocopying facility, flip charts etc. shall be arranged by BHEL and provided during the working hours for the training.
7	Pre-course material (if Any) and the course material shall be provided in advance for distribution to participants in case it is required.
8	Total number of participants shall be 20 maximum per course and any extra participant(s), if permitted by the course provider, shall be allowed to attend the course and shall be eligible to receive the certificate(s).
9	All participants shall be provided with the Certificates of successful completion in accordance with the terms of Accreditation Scheme. An examination may be conducted at the end of the course as per requirements of Accreditation Body. Those who pass the assessment process/examination will be awarded "certificate of achievement" and those who fail in the course assessment process/examination will be provided "certificate of attendance".
10	BHEL shall provide training venue, lunch, tea etc. for the participants. The course is likely to be organized in Delhi/NCR. However, the courses may also be held at other stations. In case, the course is organized outside Delhi/NCR, the travel charges, for maximum two course faculties, by air (economy class) or by train (AC II or equivalent) shall be reimbursed separately by BHEL on the production of proofs thereof. Stay arrangements (lodging and boarding) shall be made by BHEL at its own cost.
B	Qualifying Criteria:
	Bidder must fulfill the following qualifying criteria of this tender.
1	The bidder must have sufficient experience in the field of conducting such accredited training programs and must have conducted at least 10 such courses [i.e. 10 number integrated EHS lead auditor courses as described at A-1]. Against this criterion bidders are required to submit evidence in form of detailed list of integrated

	EHS programs conducted by them, giving details like dates, venue, name of participants and organisation to whom the participants belong (in case the participant have been sponsored by an organisation).
2	The bidder shall submit evidence of Accreditation. The accreditation must be for a 5(FIVE)-days Lead Auditor Course for EHS [Integrated course on EMS as per the latest version of ISO 14001 and OHSMS based BS-18001]. The evidence shall also indicate the period for which the authorization has been given.
C	General Conditions :
1	The bidder shall be able to organize and conduct the course for BHEL in Delhi/NCR, with an advance notice period of minimum 30 days by BHEL or as decided mutually. However, the dates shall be mutually agreed and fixed.
2	No advance payment will be made. Payment will be made by BHEL only after successful completion of the course and disbursement of certificates to the participants.
3	Payment bill be made only through electronic mode.
4	Rates should be inclusive of all applicable taxes and other charges, if any. However, for accounting purpose, while raising invoice on BHEL course fee and applicable taxes shall be split. The total of all charges shown in the invoice shall be equal to the rate quoted by the bidder.
5	Period of validity of offer should be <u>90 days</u> from the date of opening of tender.
6	The rates shall be inclusive of local travel expenses for faculties in Delhi/NCR region, when the course is organized in Delhi/NCR region.
7	No escalation in cost will be permitted under any circumstance.
8	BHEL reserves the right to accept or reject any or all offer without assigning any reason thereof. Also BHEL shall not entertain any correspondence from bidders in this matter.
9	TDS shall be deducted from the bill as per applicable rules and regulations.
D	Instructions to the Bidder:
1	One set of tender document (page 1 to 8) duly signed by authorized representative of bidder & stamped on each page shall be submitted as detailed further as a token of acceptance of all the terms and conditions laid down in this tender document without any deviation . All pages of tender document, including the NIT pages and <u>unpriced Price bid</u> shall be submitted (after signing & stamping on each page) as a part of the technical bid. Price shall not be mentioned by them anywhere in the techno-commercial portion of offer. Price shall be mentioned in the relevant price bid only and submitted in separate sealed envelope. In case of any clarification, bidder may contact this office. No overwriting / correction in tender documents by bidder shall be allowed. However if correction is unavoidable, the same must be signed by authorized signatory.
