Terms & Conditions	:	1. Material shall be delivered directly to site. List of tentative sites are as per annexure-1 of REG1920-20190530. Rates to be quoted on for Site delivery basis including transit insurance and freight. 2. Taxes & Duties etc. shall be payable extra at actuals. 3. Bidders to submit signed and sealed copy of all attached REG1920-20190530 and annexure of GCC as a proof of acceptance. 4. Firm Rates shall be quoted for entering into framework agreement (FA) for 01-year. Rates quoted shall be valid for 15 months from bid opening date. Multiples Orders may be placed during validity / tenure of this framework agreement. 5. Quantity indicated in NIT against each item is envisaged for one-year requirement. BHEL may place several purchase orders for smaller quantities periodically against framework agreement finalized against this NIT. Delivery time shall be within 15 days from the date of placing Purchase Order. 6. Bidders may note that after finalization of this tender, BHEL shall enter into Framework Agreement with successful bidders. Framework Agreement shall be valid for the quantity mentioned in NIT and for one-year period. BHEL may extend the Framework Agreement period/quantity by further maximum 03 months & totaling to 15 months for the entire Framework Agreement with mutual consent. However, finalization & signing of Framework agreement does not entitle any bidder to any firm order. BHEL will place purchase orders periodically in line with Framework Agreement as per BHEL's requirement. 7. Material shall be supplied in proper packed condition to avoid any damage during transportation/storage. 8. Material shall be under Guarantee/Warranty as per clause 1.b. of REG1920-20190530. 9. Tender shall be awarded to techno-commercially qualified bidder who quotes lowest landed rate on item-wise basis. Method of finalization i.e. Reverse Auction or Price bids opening shall be decided by BHEL later on based on the number of techno-commercially qualified bidders. 10. Liquidated Damages (LD): In case of delay in delivery, a penalty of 0.5% per week, maximum up to 10% of total order value on delayed portion shall be applicable. In case of quoting any deviation from the above LD clause, the offer shall be loaded in comparison statement for un-accepted portion of LD, maximum up to 10% of basic value. 11. Risk Purchase Clause:	

If the supplier fails to deliver the whole or any part of the goods or services within the stipulated delivery period mentioned in the Purchase order, BHEL shall be entitled to terminate the contract and to purchase the same or the best and the nearest available substitute from elsewhere at the risk and cost of the seller either the whole or any part of the goods/Services.

In case of deviation or non-acceptance of Risk Purchase clause, offer shall be liable for rejection.

12. Facilitation of MSE bidder:

MSE bidders are encouraged by BHEL and shall be facilitated. MSE suppliers can avail the intended benefits only if they submit along with the offer, attested copies of valid MSE certificate like EM-II certificate or NSIC certificate or Udyog Aadhar Memorandum or any other relevant certificate provided by any other body specified by Ministry of MSME, Govt under Public Procurement Policy along with attested copy of a Chartered Accountants certificate not older than one financial year. Non-submission of such documents will lead to consideration of their bid at par with other bidders. No benefit shall be applicable for this enquiry if any deficiency in the above required documents are not submitted before price bid opening/reverse auction. If the tender is to be submitted through e-procurement portal, then the above required documents are to be uploaded on the portal. Documents should be notarized or attested by a Gazetted officer.

13. Suspension of Business Dealings:
