Deviation to any of these clauses shall not be permitted in any circumstances and may lead to rejection of bid. 1. Delivery Schedule:- (i) Minimum 30 MT within 04 weeks from date of PO. (ii) Balance 124 MT within 10 weeks from PO date. 2. i) 100% direct EFT payment within 45 days after receipt subject to acceptance of material by BHEL for MSME Vendors and 100% direct EFT payment within 90 days after receipt subject to acceptance of material by BHEL for non- MSME Vendors. li) Payment through LC is normally discourage however, Bidders who insist on payment through LC should offer LC payment terms of atleast 90 days against usance LC and a loading of 0.25% will be done on their bid. iii) Any deviation in the above payment schedule will attract loading at the rate of "[Base rate i.e. Prime Lending Rate of State Bank of India (as applicable on the date of bid opening) + 6%]" for the period of relaxation sought by the bidders. 8. Third Party Inspection/Pre Inspection by BHEL of material before dispatch may be carried out at vendor's works.

9. Material shall be supplied in proper HDPE Packing for safe transportation, delivery and storage.

10. Unequal angle shall be as per attached drawing (DEV./WIN/17/01 REV00 It 001) with the tender.

11. In case of any deviation to delivery schedule, as mentioned in NIT delivery loading @0.5% per week, max. 10% shall be imposed on quoted price for comparing L-1 standing.

12. All attachment with this enquiry shall form part of this tender. Bidders are advised to read all tender documents carefully before bid submission.

13. Offer submitted by agent/dealer /stockiest on behalf of Indigenous manufacturer shall not be accepted by BHEL and offer shall be liable for rejection. Indigenous manufacturers are to deal directly with BHEL and submit their offer

14. Tender shall be awarded to techno-commercially qualified bidder who quotes lowest landed rate on lineitem-wise basis in Sealed Envelope Price Bid. **Reverse Auction shall not be conducted for this NIT.**

15. BHEL reserves the right to verify the information provided by the bidder. IN CASE THE INFORMATION PROVIDED BY VENDOR IS FOUND TO BE FALSE/ INCORRECT, THE OFFER SHALL BE SUMMARILY REJECTED. Bidder would extend all required support in verification of information.

16. Guarantee/Warranty: -Vendor shall submit a Guarantee Certificate for satisfactory performance for period of 12 months from the date of commissioning/putting into use OR 18 months from the date of dispatch, whichever is earlier. If any defect in supplied material is noticed during above period same shall be rectified/replaced free of cost to BHEL Rudrapur within a reasonable time. Guarantee Certificate shall be submitted for each consignment.
