B	PRE-QUALIFICATION CRITERIA- TECHNICAL (APPLICABLE)
	Bidder who wish to participate should have executed* at least one similar work in <u>last 7 (Seven) years</u>, ending on latest date of bid submission. The term 'Similar works' means a. **Capital / Major Overhaul & Major replacement/modification/ renovation work of Pressure parts or water walls panels or Power Cycle Piping replacement of Boiler, of not less than 190 MW. "OR" b. Erection of Boiler/ R&M of Boiler of not less than 190 MW. Notes for PRE-QUALIFICATION CRITERIA 'B': - **Separate work order for Capital/Major overhauling of Boiler & Major replacement/modification/renovation work Pressure parts or water walls panels or Power Cycle Piping replacement of Boiler can also be considered for evaluation purpose in serial "a" above. 1. Relevant supporting documents i.e. Work order copy & work completion certificates / Protocols / MOM issued from OEM/OED companies like BHEL / GE / SIEMENS / ALSTOM/PSU's / State or Power Generating Utility Owners / Principal Employers are only acceptable. 2. The word executed means: "The bidder should have completed the work up to Hydraulic test. In case of multiple units power project contract. (First Unit completion shall be considered for evaluation) even if the contract has not been completed or closed. 3. Annual Maintenance work (AMC) shall not be considered as similar works. <i>Note : -</i> 1. This is to clarify that to meet Technical Qualification criteria, either credentials for (a) OR (b) to be submitted. 2. ("") mentioned in Technical Qualification criteria is to be interpreted as "OR".
C	PRE-QUALIFICATION CRITERIA- FINANCIAL (APPLICABLE)
C.1	TURNOVER: Bidders must have achieved an average annual financial turnover (Audited) of Rs. 114.3858 Lakhs or more over last three Financial Years (FY) i.e. (2022-2023, 2023-24, 2024-25). Bidder to submit Audited Balance Sheet and Profit and Loss Account for the three years as indicated against 'C-1' above along with all annexures. In case audited financial statements have not been submitted for all three years as indicated above, then the applicable audited Statements submitted by the bidders against the requisite three years, will be averaged for three years.

	If financial statements are not required to be audited statutorily, then instead of audited financial statements, financial statements are required to be certified by a Chartered Accountant.
C.2	NET WORTH: Net Worth (Only in case of companies) of the bidder should be positive. Net worth shall be calculated based on the latest Audited Accounts as furnished above. Net worth = Paid up share capital + Reserves.
C.3	PROFIT: Bidder must have earned profit in any one of the five financial years as applicable in the last five financial years i.e. (2020-21, 2021-22, 2022-23 & 2023-24, 2024-25). Bidders to submit audited balance sheet and profit & loss. Profit shall be 'PBT' earned during any one year of last five Financial years as in mentioned 'C3' above.
C.4	Bidder must not be under Bankruptcy Code Proceedings (IBC) as on date by NCLT/ other related local authority or under liquidation/BIFR, which will render him ineligible for participation in this tender, and shall submit undertaking as per annexure enclosed with NIT to this effect.
D	Relevant documents meeting above requirement at 'B' and 'C' shall be Submitted by bidder.
E	Consideration of offer will be subject to PSPCL /Customer's approval of Bidder during tendering. (APPLICABLE)
F	Price Bid Opening (APPLICALE) Note: Price Bids of only those bidders shall be opened who stand qualified after compliance of criteria A to E
G	Consortium or JV criteria (NOT APPLICALE)

H	1 .Completion date for achievement of the technical criteria specified should be in the last 7 years ending on the 'latest date of Bid Submission' of Tender irrespective of date of the start of work. 2. Completion date shall be reckoned from the "FY quarter of BID Submission" For Example work completion on 01.01.2014 shall be considered even if latest date of bid submission is 20.03.2021. 3. MW means Megawatts. 4. Boiler Means: - Vertical Boiler consisting of "Pressure Parts", Structure and "Power cycle Piping of same/different units of same rating. 5. Pressure Parts Means: - Economiser, LTSH, Superheater coils, Reheater coils etc. 6. Power cycle Piping: -Means Main Steam, Hot Reheat, Cold Reheat & HP Bypass pipelines.
