B	PRE-QUALIFICATION CRITERIA- TECHNICAL (APPLICABLE)
	Bidder should have 'executed' at least one 'similar work' in last 10 (Ten) years, from latest due date of bid submission. The term 'Similar work' mentioned above means: - a) ** MAJOR/ MINOR/ CAPITAL MAINTENANCE OR MAJOR/ MINOR/ CAPITAL OVERHAULING OF HYDRO MACHINES OF CAPACITY ≥ 10 MW. 'OR' b) ***REFURBISHMENT / RESTORATION & REHABILITATION OF HYDRO MACHINES OF CAPACITY ≥ 10 MW. 'OR' c) ****RENOVATION & MODERNIZATION (R&M or RM&U) OF HYDRO MACHINES OF CAPACITY ≥ 10 MW. Hydro machines mean the following: - Vertical Hydro Turbine Generator (with Pelton Turbine / Francis Turbine / Kaplan Turbine) 'OR' Vertical reversible Pump Turbine generator. 'OR' Vertical Francis type Pump Motor. Notes for PRE-QUALIFICATION CRITERIA 'B': Relevant supporting documents i.e. Work order copy & work Execution certificates/Protocol/MOM issued from either Original Equipment Manufacturers/Original Equipment Designer Companies or Power Generating Utility Owners/ Principal Employers are only acceptable. *The word "executed" means: the work should have been completed upto Spinning of the Unit or in case if the contract has not been completed or closed (Due to multiple Units contact) then the first turbine Spinning date shall be considered for evaluation. MOM/Protocol having date of Spinning or Completion certificate in support of above shall be provided for evaluation of bids. In case, spinning date is not available, Work Completion Date shall be considered for evaluation. **Overhauling/Maintenance of HYDRO MACHINES here is defined as: Dismantling & Assembly of Turbine & Generator Parts. (Separate POs covering these works shall be considered as qualified).

	REFURBISHMENT/RESTORATION & REHABILITATION of HYDRO MACHINES means restoration or rehabilitation of Hydro Machines, which includes Dismantling & Assembly of Turbine & Generator Parts. *RENOVATION & MODERNIZATION (R&M or RM&U) of HYDRO MACHINES means replacement of obsolete systems with new systems, Upgrading means capacity enhancement of equipment which Dismantling & Assembly of Turbine & Generator Parts. Routine/Daily/Annual Maintenance works Contracts (AMC) shall not be considered as similar works. Note: - 1. This is to clarify that to meet Technical Qualification criteria, either credentials for (a) OR (b) OR (c) is to be submitted. 2. ("or") mentioned in Technical Qualification criteria is to be interpreted as "OR"
C	PRE-QUALIFICATION CRITERIA- FINANCIAL (APPLICABLE)
C.1	TURNOVER: Bidders must have achieved an average annual financial turnover (Audited) of Rs. 14.21 Lakhs or more over last three Financial Years (FY) i.e. (2022-23 & 2023-2024,2024-25). Bidder to submit Audited Balance Sheet and Profit and Loss Account for the three years as indicated against 'C-1' above along with all annexures. In case audited financial statements have not been submitted for all three years as indicated above, then the applicable audited Statements submitted by the bidders against the requisite three years, will be averaged for three years. If financial statements are not required to be audited statutorily, then instead of audited financial statements, financial statements are required to be certified by a Chartered Accountant.
C.2	Financial statements (Audited Balance sheet and Profit & Loss accounts) to be submitted must have UDIN. i.e. Unique Document Identification No. generated from the UDIN Portal of the Institute of Chartered Accountants of India.
C.3	NET WORTH: Net Worth (Only in case of companies) of the bidder should be positive. Net worth shall be calculated based on the latest Audited Accounts as furnished above. Net worth = Paid up share capital + Reserves.
C.4	PROFIT: Bidder must have earned profit in any one of the five financial years as applicable in the last five financial years i.e. ("2020-21, 2021-22, 2022-23, 2023-24 & 2024-25 as on date). Bidders to submit audited Balance Sheet and Profit & Loss Statement for the year as supporting documents. Note: Profit shall be 'PBT' earned during any one year of last five Financial years as mentioned in 'C.4' above.
C.5	Bidder must not be under Bankruptcy Code Proceedings (IBC) as on date by NCLT/ other related local authority or under liquidation/BIFR, which will render him ineligible for participation in this tender, and shall submit undertaking as per annexure enclosed with NIT to this effect.
D	Relevant documents meeting above requirement at 'B' and 'C' shall be Submitted by bidder.

E	Consideration of offer will be subject to BBMB-DPH/ Customer's approval of Bidder during tendering. (APPLICABLE)
F	Price Bid Opening (APPLICABLE) Note: Price Bids of only those bidders shall be opened who stand qualified after compliance of criteria A to E
