TECHNICAL SPECIFICATION FOR ECG MONITOR CUM DEFIBRILLATOR

- 1. Advanced current controlled Biphasic technology.
- 2. Should have energy selection up to maximum 200 Joules.
- 3. Should come with high resolution LCD monitor, display size should be around 120 x 90 mm or more.
- 4. Should have synchronization and cardio version.
- 5. Should have 3 lead ECG display that can be measured from cables and paddles.
- 6. Should have facility to select the energy on paddles as well as on unit.
- 7. The unit should have facility to give print out of ECG instantly after shock.
- 8. Charging time should be less than 5 seconds at maximum energy.
- 9. Should have large internal memory that stores and prints 25 ECG events.
- 10. Should work on mains as well as on rechargeable battery.
- 11. The battery backup should not be less than 5 hours on continuous ECG monitoring or 100 full energy discharges.
- 12. Should have ability to measure chest compression rate and depth in real time with visual feedback on monitor with rate and depth indicator.
- 13. Should have battery indicator on display.
- 14. Should have option for upgradable / inbuilt non invasive pacing.
