1.2	Only those vendors (OEMs) should quote, who have commissioned in the last 05 years (as on the original date of tender opening) at least TWO "PORTABLE ELECTRIC CHOPSAW WITH METAL SAW" exactly the same model proposed in the technical offer EITHER (i) In at least one country other than the country of origin to establish vendor's global business activity. OR (ii) In India, and the referred equipment are presently working satisfactorily for more than one year from the date of commissioning (as on the original date of tender opening).	
1.2.1	The supplier has to give following information about the offered model. (a) Model Name, Year of launch of the Model. (b) name and contact addresses of the customers
