## **Annexure-I**

## <u>Annual Maintenance Contract of Computer Hardware</u> (Terms and Conditions)

## **SCOPE OF THE WORK**

- Maintenance of the PCs and peripherals as per Table-1
- Maintenance for a period of two years with a provision for BHEL to short close at the end of any quarter with one month advance notice in the second year only
- Maintenance charges will be paid quarterly at the end of every three months

#### **ELIGIBILITY CRITERIA FOR BIDDERS**

The following are the pre-qualification criteria to bid for this AMC contract. Bidder should provide required proofs to demonstrate their qualifications.

- 1. Bidder should be a company/firm, registered/incorporated in India. Certification of incorporation is to be submitted.
- 2. Bidder should have provided IT services at least for the past 3 years. At least 2 order copies for Maintenance Services for similar IT assets are to be submitted with customer contact details for verification. At least one of these contracts shall be for maintenance and service of minimum 600 PCs and 400 peripherals in a single site.
- 3. Bidder should be a profit making entity for the last 3 years. Certified/ Audited balance Sheets for last 3 years should be submitted.
- 4. Bidder should have not be involved in any bankruptcy Issues. Bidder should give a declaration to this effect.
- 5. Bidder should have valid ISO:9000/ISO:27001 certification as on date of submission of the bid. Copy of the Certificate is to be attached with the bid.
- 6. Bidder should not be under Hold or Blacklisted by any of BHEL units as on bid opening date, for any of product or service related to IT. Bidder should give a declaration to this effect.

#### Note:

- 1. Certificates and evidences should be provided as a proof for all the above mentioned eligibility criteria.
- 2. If Bidder does not fulfill any of the eligibility criteria mentioned above, the offer will be rejected.

#### Other conditions:

- 1. Bidder shall quote for all items in table–1. Otherwise the offer will be rejected. The contract will be awarded to one vendor for all items and will not be split.
- 2. Bidder shall sign all the pages of the Tender document, eligibility criteria, other conditions, terms & conditions for the maintenance and all the supporting documents. Signing of the document means that Bidder has fully understood the Tender and complies with all the requirements.
- 3. All software, updates and upgrades of software of PCs and Peripherals provided by BHEL shall be installed by the bidder during the entire two years AMC period.

#### TERMS AND CONDITIONS FOR THE MAINTENANCE

- 1. Bidder shall carry out proper maintenance of the hardware / software to ensure and provide a monthly uptime of minimum 98% for PCs and peripherals.
- 2. The contract shall cover services, repairs and replacements necessary to keep the equipment in good working condition on a reasonable use of the equipment, but shall not include replacement of consumable parts such as toner, ribbons etc. Bidder shall clearly indicate in their offer for each serial number, items treated as consumables.
- 3. All service calls shall be resolved within the same day for PCs and Peripherals. Service call shall be registered thro' BHEL system / phone and not in bidder system.
- 4. At least ten qualified resident Engineers shall be posted at HPBP/BHEL-Tiruchy, one at SSTP/BHEL-Tiruchy and two at Piping centre/BHEL-Chennai to carry out maintenance of PCs and peripherals listed. BHEL will not provide any boarding or lodging facilities to the service engineers. Office space will be provided to bidder for holding essential spares.
- 5. Adequate stocks of spares shall be stocked in BHEL premises, to ensure the committed availability.
- 6. The resident engineers shall be capable of resolving hardware and software issues that crop up from time to time in the computer hardware and subject to BHEL clearance.
- 7. When an item does not perform to the committed uptime, then payment cut will be effected on pro-rata basis. Bidder may note that, in case of breakdown of any critical equipment, the payment cut will also apply to all other hardware and peripherals affected by the breakdown.
- 8. If the availability of the system or part thereof is continuously below 75% over a period of 3 months, BHEL reserves the right to terminate the contract in full without any cost implications to BHEL.
- 9. Bidder shall provide alternate equivalent system as stand by in case the failed system would take more than 48 hours to set right through normal maintenance practice. The equivalent system shall be acceptable to BHEL.
- 10. For registering and closing of service calls and for evaluating uptime / downtime, an inhouse developed web system is in place. Down time and related penalty will apply to complete or affected portion of the equipment which becomes dis-functional due to failure of any part of the equipment.
- 11. AMC period shall start from next day of current contract matured date or one week from Purchase order date whichever is later. The quarterly AMC charges become payable at the end of every three months.
- 12. The AMC is limited to a Maximum of two years. The rate shall remain constant throughout the contract period of 2 years, and throughout the life of the order. No additional charges shall be levied by Bidder during the contract period of two years.
- 13. If required, the contract may be terminated in the second year at the end of any quarter with one month advance notice.

- 14. Offers without the acceptance to all the terms and conditions will not be considered for further evaluation.
- 15. Background verification is to be done for all the resident engineers and bidder should give declaration for the same. Bio-data of all resident engineers shall be submitted for verification.
- 16. If the uptime for an item for the month is less than the committed uptime, then the payment cut will be effected as follows:
  - Payment cut in Rs. = (Downtime in hrs / 720) X (Quarterly maintenance charges / 3) X 8
    Where 8 is the penalty factor.
  - The total of such payment cut is subject to a maximum of total quarterly charges for all the items.
- 17. Periodic maintenance / repair shall be carried out in all batteries. The failed batteries in UPS / servers / PCs shall be replaced by the bidder immediately.
- 18. Bidder should provide necessary tools and instruments to the Service Engineer for the purpose of servicing the equipment covered by the contract.
- 19. BHEL reserves the rights to increase or decrease the enquiry quantity or delete a particular item while placing the purchase order.
- 20. Price bid format is given in Table 2.
