- The standard drum length shall be 1000 meters as indicated above. Tolerance on individual drum length shall be ±5%.
- Overall tolerance on total dispatched quantity of each size shall be (-) 2% and (+) 0% except where the total ordered quantity is one single drum length of 1000m, in which case it shall be -5% to 0%. Cables consumed for testing and inspection shall be to bidder's account.
- For each individual cable size, one short length of not less than 500m may be accepted only in the final drum length to complete the supply (except where the total ordered quantity is one single drum length of 1000m). The overall tolerance limits stipulated above shall continue to apply (in case short lengths are accepted).
- For type test requirement please refer clause no. 4.2 of Technical Data -Part-A of technical specification.
- For PVC formulae & Indices; please refer "https://ieema.org/wp-content/uploads/2020/07/Cable-2017_Revised-PVClause_low-res.pdf" or latest amendment (if any) with upper ceiling limit of 20% & no negative ceiling limit.
- UNIT PRICE DERIVED AS ABOVE, SHALL BE BINDING FOR ANY QUANTITY VARIATION, WHICH IS AT THE DISCRETION OF PURCHASER.
- SUPPLIER TO GIVE SINGLE % OF FREIGHT CHARGES CONSIDERING ANYWHERE IN INDIA IN THE FREIGHT COLUMN.
- SUPPLIERS TO MENTION APPLICABLE GST RATE ON (TOTAL EX-WORKS + FREIGHT) IN THE SPECIFIED CELLS OF PRICE SCHEDULE. HOWEVER, MAY PLEASE NOTE THAT GST SHALL NOT BE CONSIDERED IN THE EVALUATION.
- REST OF THE PRICES SHALL BE DERIVED BY BHEL IN LINE WITH ALLOCATION FIXED FOR EACH ITEM. THERE IS FORMULA APPLIED IN PRICE SCHEDULE FORM AVAILABLE IN E-PROCUREMENT PORTAL. AS SOON AS, SUPPLIER FILLS THE CELLS FOR TOTAL EX-WORKS, FREIGHT PERCENTAGE AND GST PERCENTAGE, REST VALUES FOR E.G. UNIT EX WORKS – ITEM WISE, TOTAL EX WORKS – ITEM WISE, F.O.R.
