PREAMBLE	
1.0	This preamble forms part of tender document and schedule of items. The tenderer should read this preamble carefully in rates for various items. Clauses under this preamble shall be read in conjunction with other volumes of tender as applicable.
2.0	The work shall be carried out strictly as per specifications, description of the items in these schedule and / or engineer's instructions.
3.0	Items of work provided in this schedule but not covered in this specification shall be executed strictly as per instruction of the engineer.
4.0	Unless specifically mentioned otherwise in the tender document, the tenderer shall quote for the complete job for transportation of all consignments as per Annexures I (A, B & C), II, III & IV to their respective destination including all related jobs essentially required for completion of the contract according to the tender document and this schedule.
5.0	The items/quantities/weights of the various transportations mentioned in this schedule of items are approximate, based on preliminary information .
6.0	The weight of the various items mentioned in Annexure - I (A, B & C), II, III & IV of Technical Specification & SCC are approximate, based on very preliminary information and may vary to any extent or be deleted altogether for individual items. The actual weight may vary up to +/-30% and shall be known at an appropriate stage from BHEL. However, the total variation in quantity(weight) of consignments in Annexures I (A, B & C), II, III & IV taken together will be limited to +/-30% of total weight of tendered total quantity. Transportation charge of consignment will be paid on actual weight as mentioned in weight bridge slip/packing list. Transportation charge of additional materials (if any) shall be paid on rate as per contract.
7.0	Prior written approval of BHEL shall be sought by the contractor in case quantity (weight) variation of any item crosses +50% (plus fifty percent) limit during execution, an approval to be obtained before execution of further quantity for this item.
8.0	The rates quoted shall be inclusive of all related jobs essential for completion of contract. No separate payment will be made towards the same.

PREAMBLE	
9.0	Rates shall be quoted in figures and in words in clear legible writing. No overwriting is allowed. All scoring and cancellations should be countersigned and in case of illegibility the interpretation of engineer shall be final. All entries shall be in English language.
10.0	All works item wise shall be considered upon completion and paid for at the rates quoted and accepted.
11.0	The tender shall be deemed to have studied the specifications, details of work to be done within the time schedule attached and to have acquainted himself of the conditions prevailing at site.
12.0	Engineer's decision shall be final and binding on the contractor regarding clarification of items in the schedule with respect to the other sections/volumes of the contract.
13.0	Evaluation shall be on total quoted price as per SCH-1 only.
14.0	All works item wise shall be measured upon completion and paid for at the rates quoted and accepted as per BHEL approved payment schedule/billing break-up.
15.0	No Splitting of the job is envisaged unless the same is specifically indicated in Technical Specifications & Special Conditions of Contract (Vol-ID & II). Decision of BHEL in this regard shall be final and binding to the bidders.
16.0	Bidders are not allowed to alter the Price Schedule format including item description, quantity etc. and the offer is liable for rejection if the bidders submit their prices in Price Schedules modified by them. BHEL reserves the right to reject the offers of bidders who submit offers in Price Formats which are modified/altered by them. Also putting any comments instead of rates/price in the designated column of the rate schedule shall make the offer liable for rejection.
17.0	No interest, whatsoever, shall be payable by BHEL on the security deposit, any bank guarantee submitted or any amount due to successful bidder/contractor.

The rates of individual items shall be derived from the amount against each items and its quantity after rounding off to upto 7 decimal places. However, RA bill payment shall be done after rounding off the gross amount to two decimal points. Any adjustment, if required, due to such methodology, will be effected / adjusted in final bill.		
4.0	Bidder shall note that while the allocated price of SCH-2 correspond to their respective prices, rates of various components will be worked out by apportioning the amounts w.r.t. respective indicated quantities/weights mentioned in SCH-3 & SCH-4.
