- Bidder has to quote only Total Ex-works Value 'X' at SL NO-A.3 OF COLUMN 11 of this sheet and freight percentage in the designated column. The item wise break up of Ex works prices (unit as well as total) for all the items in the BOQ shall be derived as per the formulae indicated above by BHEL.
- Bidder to note that evaluation shall be on Total Ex works price + Freight.
- Bidder shall furnish this price Schedule indicating "Quoted/Not-Quoted" along with technical offer and actual prices in his price offer.
- Quantities indicated above shall be known as Order Quantities. The variation in quantities of cables put together shall be limited to (+/-) 30% of the total contract value derived on the basis of order quantities.
- Manufacturing of the Lot-1 quantities of cables indicated above shall be taken up by the successful bidder only after approval of technical and quality documentation in Cat-I or separate manufacturing clearance issued by BHEL, whichever is earlier. Subsequent lots shall be cleared for manufacture based on progress of engineering & site requirements.
- Delivery schedule of LOT-1 and subsequent lots shall be as per NIT.
- The standard drum length for power cables shall not be less than mentioned against each cable size above. The length per drum shall be subjected to a maximum tolerance of +/- 5% of the standard drum length.
- Overall tolerance on total dispatched quantity of each size shall be (-) 2% and (+) 0%. Cables consumed for testing and inspection shall be to bidder's account.
- For each individual cable size, one short length of not less than 200m may be accepted only in the final drum length to complete the supply. The overall tolerance limits stipulated above shall continue to apply (in case short lengths are accepted).
- Bidder shall indicate prices of cables inclusive of type test charges. No separate charges shall be payable for type tests.
- In case the quantities cleared by BHEL for manufacturing (in a lot) are manufactured and offered for inspection by successful bidder in more than one batch, BHEL reserves the right to witness type testing on all batches without any price implication.
- Following GOI notifications (attached with NIT as Annex G) shall be applicable for GST for exports: (i) Notification No. 41/2017- Integrated Tax (Rate) dt. 23.10.2017 regarding IGST @0.1% (ii) Notification No. 40/2017- Central Tax (Rate) dt. 23.10.2017 regarding CGST @0.05% (iii) Notification no. 1663 dt. 16.11.2017 regarding SGST @0.05%.
