	<u>PRE-QUALIFICATION CRITERIA:-</u>	
1	The vendor must have supplied minimum 15 MT of Nickel of minimum 99% purity in one financial year within a period from 01.04.13 to the date of tender opening (techno-commercial bid tender opening date).	
2	As a supporting document, copy of Purchase Orders/ Purchase Agreements/Invoice of cumulative quantity of 15 MT of Nickel of minimum 99% purity supplied in one financial year within a period from 01.04.13 to the date of tender opening (techno-commercial bid tender opening date) has to be provided by vendor along with their offer.	
	<u>TECHNO-COMMERCIAL TERMS:-</u>	
1	Material – Nickel - shall be supplied as per specification no. FF05061 Rev 02 (attached with enquiry) in all respect i.e. size, chemical composition, inspection, test certificate, packing & marking etc. without any deviation and the seller confirms agreement of all the clauses of the said specification. Material found in nonconformity to conditions of specification no. FF05061 Rev 02 shall be rejected.	
2	For payment for accepted material in the specified range, no pro rata rate will be permitted for any constituent element in the material.	
3	Guarantee Certificate shall be provided by the seller along with despatch documents confirming that in case of any non-conformity with respect to the specification No. FF05061 Rev 02 , the supplied material shall be replaced free of cost.	
4	Original Manufacturer's Test Certificate (with linkage to supplied material) shall be provided along with dispatch documents. Material shall be supplied in original manufacturer's packing with marking as per specification.	

5	Third party inspection (before despatch) from one of the following six inspection agencies i.e. BVC/ DVN/ TUV(SUD)/ SGS/ALEC STEWARD/ ALFRED H-KNIGHT shall be arranged by seller at their own cost. Third party inspection report should include test results as per requirement of tender enquiry specification. Scope of third party inspection is attached. Report of third party inspection shall be submitted along-with dispatch documents. Acceptance of material shall be after final inspection at CFFP BHEL Haridwar as per tender enquiry / PO specification and shall be binding on seller. Material not found in conformance with applicable specification & purchase order conditions will be rejected. In case material gets rejected during final inspection at CFFP the same shall be replaced by supplier immediately. All the charges (like To & Fro freight, insurance etc.) for replacement shall be borne by supplier. Date of receipt of replacement material if accepted shall be considered as actual delivery date with respect to the PO delivery date for calculating penalty for Late Delivery.	
6	Scope of Third party Inspection:- i) Witnessing the Chemical analysis as per CFFP specification no. FF05061, Rev.02 ii) Witness packing and loading of product. Third party inspection seal to be put on each drum. iii) Seal should be placed on drum so that same should not get damaged during transit/transportation. iv) Detailed Scope of third party inspection is attached with tender enquiry.	
7	Material to be supplied by vendor in sealed container to CFFP, sealed by custom/ third party inspection agency. Lot quantity will be 20 MT.	
8	Delivery Term :- A. <u>For Indian Suppliers:</u> <u>FOR</u>, Destination (Door delivery basis). Destination will be C.Store, CFFP, BHEL, Haridwar. B. <u>For Foreign suppliers:</u> On CIF, Nhava Sheva , Mumbai Quoted rate should be inclusive of the charges like freight, service tax on freight, insurance, packing & forwarding etc. <u>for the delivery term</u> given above or else proper loading shall be done.	

9	<u>Delivery Schedule :-</u> A. <u>For Indian Suppliers:</u> 1st lot of 20 MT–within 30 days from P.O. date 2nd lot of 20 MT– within 60 days from P.O. date 3rd lot of 20 MT – within 90 days from P.O. date B. <u>For Foreign suppliers:</u> 1st lot of 20 MT F.O.B. delivery–within 15 days from L.C./P.O. date 2nd lot of 20 MT F.O.B. delivery– within 45 days from L.C./P.O. date 3rd lot of 20 MT F.O.B. delivery– within 75 days from L.C./P.O. date , whichever is later. L.D. will be applicable as per above mentioned delivery schedule.	
10	<u>Conditions for opening of Price :-</u> <i>BHEL reserves the right to go for Reverse Auction (RA) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. All bidders to give their acceptance for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.</i> <i>In case BHEL decides to go for Reverse Auction, Only those bidders who have given their acceptance to participate in RA will be allowed to participate in the Reverse Auction. Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit „online sealed bid“ in the Reverse Auction. Non-submission of „online sealed bid“ by the bidder will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines in vogue.</i> <i>In case BHEL decides to go for Reverse Auction, the H1 bidder (whose quote is highest in online sealed bid) may not be allowed to participate in further RA process.</i>	

11	Evaluation of price bids (for deciding L-1) will be done on the basis of total delivered cost at CFFP i.e. Landed cost net of Cenvat at CFFP. This will be calculated based on average LME cash settlement price of Nickel for the month (one month prior to techno-commercial tender opening date) plus premium charge plus taxes & duties payable. Exchange rate will be taken as TT selling rate of SBI card rate for the date of techno-commercial tender opening. <u>Note:- Vendor has to quote premium charge in per Kg separately in their offer. In case, vendor does not quote premium charge separately in their offer, their offer will be ignored.</u> Vendor has to clearly mention taxes & duties applicable in their offer.	
12	<u>Basis of payment:-</u> i) Av. LME Cash Settlement Price of Nickel during the calender month of shipment plus ii) premium charge indicated by vendor per Kg of Nickel plus iii) taxes & duties payable against submission of documents.	
13	For payment to Indian vendors, Exchange rate will be taken as TT selling rate of SBI card rate of 15th date from date of B/L. Payment to Indian vendors will be made in Indian Rupees.	
14	Payment Terms: <u>For Indian suppliers</u> – (a) FOR C.Store, CFFP basis:- 100% within 30 days after receipt & acceptance of material at CFFP / BHEL, Haridwar through e-payment.(Custom duty, Custom clearance and other taxes, insurances, etc. will be to vendor's account.) (b) High sea sale basis (Port of Discharge- Nhava Sheva):- 100% within 60 days from the date of receipt of clear sale documents at BHEL ROD, Mumbai however after receipt & acceptance of material at CFFP/BHEL, Haridwar through e-payment. (Sale documents have to be handed over to BHEL, ROD, Mumbai within 3 days from the date of high sea sale date. Custom clearance will be to BHEL account. High sea sales for any other port will not be acceptable. In case of delayed submission of documents to BHEL ROD or providing incomplete documents for custom clearance, demurrage charge will be recovered from vendor. Also material will be transported in sealed container. To and fro charges of container through trailer will be loaded for landed price	

	calculation.) Loading will be @ Base rate of SBI (as applicable on the dated of bid opening, Techno-commercial bid opening in case of two part bids) + 6%, shall be considered for loading for the period of relaxation sought by bidders. For foreign suppliers: Payment through USANCE LC on 70th day of bill of lading date. All bank charges shall be to vendor's account. In case vendor does not agree, proper loading shall be done. Also Third party pre-despatch inspection shall have to be arranged by supplier from any of the six inspection agencies namely: BVC/ DVN/ TUV(SUD)/ SGS/ALEC STEWARD/ ALFRED H-KNIGHT at their own cost. Loading will be @ Base rate of SBI (as applicable on the dated of bid opening, Techno-commercial bid opening in case of two part bids) + 6%, shall be considered for loading for the period of relaxation sought by bidders.	
15	Validity of offers: minimum 45 days from tender opening date(Techno-commercial bid opening date in case of two part bids).	
16	BHEL may place order for part quantity. Quoted rate not to be linked with order quantity.	
17	Material will be supplied as per delivery schedule required in tender enquiry / PO (FOR destination basis). Any request for extension in delivery schedule of Purchase Order / waiver of LD is liable to be ignored.	
18	Normal clauses for imposing Penalty for Late Delivery, Risk purchases, Cancellation, Arbitration in case of delay in effecting supply and or other defaults as per following conditions will be applicable: - Penalty for Late Delivery: The delivery of the goods shall be made strictly as per time limit specified in delivery schedule, failure to supply within this period will make the seller liable to a penalty of 1/2 (half) percent of the price of the goods in arrears per week subject to a maximum of 10% on the basic rate (total PO value). Any correspondence regarding waiver of LD shall not be entertained. In case supplier does not agree for LD clause, BHEL will load maximum penalty under LD clause, to the extent the same is not agreed by the vendor, for the purpose of comparative statement. Where deliveries quoted are not suiting, BHEL may ignore the offer. - Risk Purchase: In case of delays in supplies / defective supplies or non-fulfillment of any other terms and conditions given in the Purchase Order by the seller, the Buyer reserves the right to cancel the purchase order in full or part thereof, and may also make the purchase of such material from alternative source <u>at the risk and</u>

19	For new vendors who are not registered with CFFP BHEL Haridwar, please submit duly filled up "Supplier Registration Form (SRF)" (available at www.bhel.com) /statutory documents as per SRF along-with techno-commercial bid of offer.	
20	BHEL will prefer to deal directly with foreign vendor/ original manufacturer. In case, vendor engages any Indian agent or take service of any Indian agent, copy of agent agreement required along with offer in line with Annexure-IV attached.	
21	In the event of any dispute arising out of contractual obligation, the order being finalized at Haridwar, India will be subject to Indian Laws and falls under jurisdiction of the court of Law at Haridwar, India.	
22	Indian Vendors shall quote their premium charge only in INR. Foreign vendors shall quote their premium charge only in USD, EURO, UK POUND STERLING and JAPANESE YEN. For evaluation of price bids, exchange rate (TT selling rate of SBI) as on scheduled date of tender opening (Part-1 bid in case of two part bid) shall be considered.	
23	Vendor shall quote price both in words & figures. If there is any difference between price quoted in words & figures, price quoted in words shall prevail and binding.	
24	<u>Conditions to break ties in landed price:-</u> a. Cases where landed price of two or more vendors are same then while ordering preference will be given to Vendor whose conditions are favourable to CFFP. If all conditions are same for vendors then the vendor whose SPR is more shall be given preference. b. First time vendor (new vendor) or vendor who has not executed any PO in material category of tender enquiry item/s, their Supplier performance rating (SPR) will be treated as zero. c. In case, SPR of vendors are equal, then quantity will be distributed equally between those vendors who have quoted lowest landed rate. If quantity ordered is only one piece or where quantity can't be divided equally, then preference will be given to vendor whose quality rating is more. If quality rating is also same then ordering will be on vendor whose delivery rating is better.	

25	A. In case of any difference in conditions quoted above & elsewhere in the offer, terms quoted above shall be treated as final and binding on vendor. B. Non acceptance of any of the above conditions may result in rejection of your offer.
