GENERAL TERMS AND CONDITIONS FOR M&S MECHANICAL CONTRACTS

- 3) The contractor should mention the point to point confirmation.
- 4) Contractor should commit for Terms and Conditions of the enquiry otherwise the offer shall be liable for rejection.
