#### **DEDUCTION**

- 16. The driver of the vehicles should be well behaved and courteous with the passengers. He should display restraint and wisdom in dealing with excited passengers. In case of misbehavior by the driver, a penalty of upto Rs.50/- can be imposed for each occasion. In case there are multiple repetitions with a particular driver, he will have to be changed.
- 17. One set of cleaned & ironed white seat covers will have to be kept ready for providing during VIP visits. In case of failure to do so, BHEL will get the same prepared and deduct the amount from the bills apart from recovering a penalty of Rs.500/- per vehicle.

- 19. This dress shall become the property of the contractor/driver after 1 years provided the uniform is worn regularly. In case the uniform is not worn, penalty @ Rs.10 per day is liable to be levied. In case this continues for more than 30 days, the amount of Rs.500/- can be recovered back.
- 20. The driver will have to be provided with a mobile phone. He will keep the mobile phone charged and in fully operative condition. Failure to keep/keep ON the mobile phone would entail a penalty of Rs.50/- per day subject to maximum Rs.500/- per month per vehicle.
- 21. The contact person mentioned in Part-'A' of this bid will have to meet the Pool Supervisor at least once every fortnight for obtaining feedback about the operation of the taxies. The instructions issued by the Pool Supervisor will be noted down by the contact person in Two Copies, one each for the contractor and BHEL. Non-reporting in any fortnight can result in a penalty of Rs.100/- for each lapse. Failure to comply would result in deduction of penalty of 10% cost of the rate/trip charges.
- 26. Placard indicating name of Guest, name of Company etc. will have to be displayed by the driver at the Railway station for receiving incoming guests. The Transport Pool In-charge will give details from time to time. Failure to comply with this provision may result in a penalty of Rs.100/- per incident. Each vehicle has to keep two sketch pens, white sheets, blade & cello tape for writing the name of the arriving guest and paste it on the front wind screen.
- 27. In case the vehicle goes out of U.P. State on BHEL duty, the service provider has to obtain road permit for the same. Expenditure incurred on this account shall be reimbursed along with the payment of bill on documentary proof. Failure to timely arrangement of permit would result in a penalty of upto Rs.500/- per incident.
- 28. The Car will have to be maintained by the contractor in good running condition which includes at least the following:
  - i. Minimum noise of engine and body while running;
  - ii. Tyres with proper treads;
  - iii. Inflated Stepney;
  - iv. Working headlights, tail lamps, indicators, speedometer, milometer, temperature indicator etc;
  - v. Proper paint on the outside;
  - vi. Good condition of bumpers;
  - vii. Upholstery in good condition including washed and ironed white seat covers;
- viii. Proper locking of all doors;
- ix. Proper closing and opening of all windows:
- x. Dusting of dashboard, rear board, matting, windscreen, windows and body.

Language of the Arbitration proceedings shall be in English. The venue of Arbitration shall be Jhansi, India. The court of Jhansi shall have exclusive jurisdiction.

- 40. Any matter of dispute arising out of or in connection with this contract shall be under jurisdiction of Jhansi Court only.
- 41. The Contractor has to make an agreement with BHEL in the format prescribed only on Rs. 100/- Non-Judicial Stamp Paper.
- 42. In case of non satisfactory performance of the contract and/or any irregularity in meter reading/ log book, Tampering in Milometer etc., BHEL shall have a right of forfeiting the security deposit and cancellation of the contract.
