IMPORTANT TERMS FOR PRICE BID & RATE BASIS:

1. Refer conditions for contract finalization of techno-commercial bid (Part-II).
2. The rate quoted should be **exclusive of diesel cost**, as BHEL will provide diesel to forklift for day-today operation.
3. The quoted rate should be excluding GST and inclusive of any taxes and duties levied or to be levied both by Central and State Government authorities from time to time. Such levies should be borne by the Contractor. GST will be paid extra on submission of documentary evidence.
4. The quoted rate shall be firm throughout the currency of the contract.
5. Vendor can quote for any one schedule or both schedule as per their choice. Contract for both the schedule will be finalized independently.
6. Evaluation of the offer shall be done on the basis of delivered cost (i.e. “Total Cost to BHEL”).
7. The quoted rate will be inclusive of the charges for the Forklift along with manpower (One driver for single shift and two driver for double shift with each forklift and one common supervisor from each contractor), lubricants, tool, spares and personal protective equipment’s, PF, ESI, Bonus etc., covering all statutory requirements.
8. **CLARIFICATION REGARDING GST:** In case any changes in taxes and duties as per Govt. Notification (including GST), the same shall be applicable from time to time.
