	<p>DESCRIPTION OF PEST CONTROL SERVICE IN SUB-STATIONS.</p> <p>1) Many occasion substation operations have been disrupted by rodents which damaged internal control cable, power cable causing short circuits in HT/LT Bus bars of MV Panels, HT panels and interrupting power supply to production shops. In order to prevent such occurrences, It is essential to deploy rodent control provisions to be placed in all our substation of HPBP complex.</p> <p>2) Treatment against rats, mice and bandicoots. For the control of rodents, required to use the anticoagulant rodenticides, which is safe to be used in human habitation. The anticoagulant Bromodiolone should not have pre-baiting, secondary poisoning and bait shyness. Product required should be in the form of weatherproof wax blocks, highly attractive and palatable to rodents.</p> <p>3) Mode of Treatment taken care to be taken by vendor. The treatment should commence with strategic placement of baits in the bait stations (Approx. 6 Nos / Substation) to bring the infestation under control. Also the rodent burrows within BHEL compound area should be baited. - 5) UPON RELEASE OF THE WORK ORDER THE PERFORMANCE OF THE CONTRACT WILL BE REVIEWED AFTER SIX MONTHS. IN CASE,IF IT IS ESTABLISHED, THAT THE EFFECTIVENESS OF THE RODENTICIDE IS NOT SATISFACTORY, THEN BHEL SHALL PROCEED TO SHORT CLOSE THE WORK ORDER PREMATURELY AFTER MAKING PAYMENT UPTO THAT PERIOD. BHEL'S DECISION SHALL BE FINAL AND BINDING IN THIS REGARD.
- 6)TOTAL CONTRACT PERIOD SHALL BE DIVIDED INTO FOUR QUARTERS AND PAYMENT WILL BE MADE AT THE END OF EACH QUARTER ON SUBMISSION OF INVOICE IN TRIPLICATE CERTIFIED BY THE ENGINEER IN CHARGE.

GENERAL TERMS AND CONDITIONS FOR M&S CONTRACTS

- 1) The workmen of contractor should be covered under PF/ESI, etc as per labour laws.
- 2) Safety precautions have to be ensured by the Contractor Depending on the work nature. Necessary work permit system and personal protective equipments (PPE) such as electrical resistance rubber gloves, helmet, spectacle goggles, safety shoes, safety belt etc. as applicable to Mechanical works should be adhered while carrying out the work.
- 3) PPES for appropriate trade job has to be ensured by the contractor at the job site at all times.
- 4) The contractors may visit the area to assess the quantum of work before quoting.
- 5) The contractor should mention the point to point confirmation.
- 6) Contractor should commit for Terms and Conditions of the enquiry otherwise the offer shall be liable for rejection.
- 7) **TWO PART BID SYSTEM:** Contractor should send their offer for two part bid system as below
