GENERAL TERMS AND CONDITIONS FOR M&S CONTRACTS

- 1) The workmen of contractor should be covered under PF/ESI, etc., as per labour laws.
- 2) Safety precautions have to be ensured by the Contractor Depending on the work nature. - 4) The contractors may visit the area to assess the quantum of work before quoting.
