SCOPE OF WORK

I. For AC servicing and breakdown maintenance of various makes for 24 Months

Servicing:

1. Air filter has to be cleaned (water wash).
2. Condenser coil and cooling coil are to be cleaned with air blower.
3. Outdoor unit fan motor has to be cleaned with cotton waste.
4. Outdoor unit fan blade has to be cleaned with soap oil.
5. Indoor unit blower Impeller strings are to scrapped and cleaned with air blower.
6. Entire air conditioning system has to be cleaned with air blower. Then the compressor base plate, fan motor base plates are to be cleaned with cotton waste.
7. Outer cover (inner side) has to be cleaned with cotton waste (in case of MS) or cotton waste soaked with soap oil.
8. Condenser coil and cooling coil are to be water serviced (to remove oil and heavy clogs) with soap oil.
9. Front grill has to be water washed and cleaned with soap oil.
10. Fan motor has to be oiled.
11. Necessary arrangements shall be made by the Vendor to attend ACS which are above ground level (FEW ACS are at a height of 10' / 20' / 25')

II. CLEANING and SERVICING OF WATER COOLERS:

1. Water cooler outer sides including top door are to be cleaned with soap oil.
2. Condenser coil, tank base plate, compressor base plate are to be cleaned with air blower and then to be cleaned with cotton waste.
3. Condenser fan motor has to be cleaned with cotton waste.
4. Fan blade also has to be cleaned with soap oil.
5. Tank has to be cleaned with **Bleaching powder** thoroughly and fill water to required level. Float ball assembly to be checked till the water level maintained without overflowing.
6. Fan motor has to be oiled.

III. CLEANING and SERVICING OF DEEP FREEZER and Oil Chiller:

1. Condenser coil, fan motor, fan blade, compressor base plate are to be cleaned with air blower and then with cotton waste.
2. Fan motor has to be oiled.
3. Water drain valve has to be checked for clogging and cleaned.
4. Outer sides including top door are to be cleaned with soap oil.

IV. CLEANING and SERVICING OF REFRIGERATORS:

1. Condenser coil has to be cleaned with air blower and fine edges are to be cleaned with painting brush.
2. Compressor, compressor base plate are to be cleaned with cotton waste.
3. Outer side including top side has to be cleaned with soap oil.
4. Inner side (cabinet) has to be cleaned with damp cotton waste.
5. If refrigerator is mounted on fibre on PVC stand, then it has to be washed with water and dried.
6. Door gasket (magnet) has to be cleaned with brush/cotton waste properly without damaging the gasket.

V. CLEANING and SERVICING OF PANEL ACS:

1. Condenser coil, cooling coil are to be cleaned with air blower. Compressor has to be cleaned with cotton waste.
2. Impeller motor, condenser motor are to be cleaned.
3. Drain water line (PVC pipe) has to be cleaned.

VI. CLEANING and SERVICING OF WALK-IN COOLER:

1. Compressor, Fan motor and their base plates are to be cleaned thoroughly.
2. Condenser coil has to be cleaned with air blower and then water washed. Condenser fins are to be cleaned with brush and then by air blower.
3. Condenser unit fan motor and cooling unit fan motor are to be cleaned with cotton waste.
4. Cooling coil has to be water washed and the cooling fins are to be cleaned by air blower.
5. Drain water base plate has to be cleaned thoroughly.
6. Fan motor has to be oiled.

VII. CLEANING Water Tank OF WATER COOLERS:

Water Tank and Water Cooler body should be cleaned by liquid soap and pure water thoroughly.

Note: Supply of All the consumables like Soap Oil, Cotton waste, Lub oil , Ladders, Safety Belt, Helmet, Safety shoes, etc. are in the Vendor's scope.

BREAKDOWN MAINTENANCE

- 1) Necessary spares for replacement will be supplied by BHEL
- 2) Vendor to attend the breakdown & prove the performance of the AC Units / Equipment's
- 3) Faulty component to be hand over to BHEL.
- 4) All Tools, & Meters vendor scope.

PRE-QUALIFICATION REQUIREMENT

- A. The average financial turnover of the contractor during last 3 years out of last 5 financial years (beginning from 01.04.2017 -31.03.2022) should be at least Rs.4.08 lakh. While calculating Annual Turnover / Sales, other operating income and other income shall not be considered.

- B. The contractors should be successfully completed the similar work i.e. 'AMC for Split ACs, or Cassette Acs or Windows Acs or Machine panel ACs' during the last 7 years ending on 31.01.2023 should be either of the following:

19. QUOTING: **The tenderer should quote total lump sum amount as per BOQ and scope of work.**

44. Discrepancy in "words "& "Figures ":

- a) If, in the price structure quoted for the required goods/services/works, there is discrepancy between the unit price and the total price (which is obtained by multiplying the unit price by the quantity), the unit price shall prevail and the total price corrected accordingly, unless in the opinion of the purchaser there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price corrected accordingly.
- b) If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected; and

1. The manpower may be increased or decreased depends upon quantum of work.  - j) All temporary electrical connections shall be properly earthed, insulated and periodically checked.
 - k) The contractor should arrange WORKMEN COMPENSATION/ INSURANCE POLICY covered for all his/her workmen. A copy of the policy has to be submitted before commencement of work.

1. DEFINITION: -

In these General Conditions of Contract, the following terms shall have the meaning hereby assigned to them, except where the context otherwise requires: -

- a) The "Contract" means, the documents forming the tender and acceptance thereof, together with all the documents referred to therein including general and special conditions to contract. - c) The "Contractor" means, the individual firm or company whether incorporated or not, undertaking the work and shall include the legal personal representatives of such individuals or the persons composing the firm or company or the successors of the form or company and the permitted assigns of such individual or firm or company.
- d) "The officer-in charge" means, the office deputed by the AGM/WCM to supervise the work or part of the work.
- e) "Approved" and "Directed" means, the approval or direction of AGM/WCM, or person deputed by him for the particular purposes.
- f) "BHARAT HEAVY ELECTRICAL LIMITED" (herein after referred to as BHEL) shall mean the Board of Directors, Chairman, Executive Director, General Manager or other administrative office of the said company including AGM/WCM authorized to invite tenders and enter into contract for works on behalf of the company.
- g) The "Contract sum" means, the sum accepted or the sum calculated in accordance with the prices accepted in tender and / or the contract rates as payable to the contractor for the execution of work during the currency of the contract.
- h) A "week" means, seven days, without regard to the number of hours worked or not worked in any day in that week.
- i) A "day" means, the day of 24 hours (Twenty-Four) irrespective of the number of hours worked or not worked in that day.
- j) A "working day" means, any day other than that prescribed by the NEGOTIABLE INSTRUMENTS ACT as being a holiday, and consists of the number of hours of labour as commonly recognized by good employers in the trade in the district where the work is carried out or as laid down in the BHEL regulation.

2. HEADING TO THE CONTRACT CONDITIONS: -

The heading to these conditions shall not affect the interpretations thereof.

- e) Securities available from Indian Post offices such as National Savings Certificates, Kisan Vikas Patras etc. (held in the name of Contractor furnishing the security and duly endorsed/ hypothecated/ pledged, as applicable, in favour of BHEL).

(Note: BHEL will not be liable or responsible in any manner for the collection of interest or renewal of the documents or in any other matter connected therewith).

24. CANCELLATION OF CONTRACT FOR INSOLVENCY ASSIGNMENT OF TRANSFER OR SUBLETTING OF CONTRACT: -

BHEL, without prejudice to any other right or remedy, which shall have accrued or shall accrue thereafter to BHEL shall cancel the contract in any of the following cases:
If the contractor,

- c) Assigns, Transfers, Sub-lets or attempts to assign, transfer or sub-let any portion of the work without the prior written approval of the BHEL.

- d) Whenever BHEL exercise the authority to cancel the contract under this conditions, BHEL may have the work done by any means at the Contractor's risks and expenses provided always that in the event of the cost of the work so done (as certified by concerned executive of MTD department which is final and conclusive) being less than the contract cost, the advantage shall accrue to the BHEL and if the cost exceeds the money due to Contractor under the contract, the Contractor shall either pay the excess amount ordered by AGM/WCM or the same shall be recovered from the Contractor by other means.

However, no such recovery shall be enforced after three years of passing the final bill.

30. SIGNING OF CONTRACT: -

Each contract document shall be signed by the Contractor with his usual signature. Contract by partnership of Hindu Joint Family firm, may be signed in the FIRM'S name by one of the Partners or the Karta or Manager as the case may be or by any other duly authorised representative followed by the name and designation of the persons so signing. Contracts by a Company shall be signed with the name of the Company by a person authorised in this behalf and a power of attorney or other satisfactory proof showing that the persons signing the Contract documents on behalf of the Company is duly authorised to do so, shall accompany the contract.

31. FORCE MAJEURE CLAUSE: -
