BHEL reserves the right to extend the period of this agreement by a period of six months or part thereof at one or more occasions or truncate the period by a period of 6 months or part thereof depending on the performance of the CONTRACTOR in executing the work by giving a notice of 15 days.

BHEL also reserves the right to have executed by the CONTRACTOR for any other category not covered under this agreement at mutually agreed rates & terms.

Hence, the Contractor shall do all the necessary works for transportation of goods for all the destinations to be communicated from time to time in accordance with the provisions of this agreement.
