<u>CIVIL AND STRUCTURAL PACKAGE – MODFICATION IN PQ PROPOSED FOR CIVIL AND STRUCTURAL PACKAGE VENDORS</u> (APPLICABLE FOR CIVIL AND STRUCTURAL PACKAGE)

PRESENT PQ:

- a) Bidder should have designed, engineered and executed the following works within the preceding seven (7) years as on the date of bid opening:
 - i. Basement type structures like Track hoppers, Wagon Tipplers, Tunnels etc. involving deep excavation and extensive dewatering and industrial buildings with finishing works for minimum depth up to (-)12.0 m below ground level.
 - ii. Minimum 13,000 cu.m. of reinforced cement concrete work in any one (1) year in a single contract.
 - iii. Minimum 3500 MT of fabrication and erection of steel structures in a period of any one (1) year in a single contract.
- b) Average annual turnover of the bidder, in the preceding three (3) financial years as on the date of bid opening, shall not be less than Rs 100 Crores.
- c) i. In case, the bidder is not meeting either civil or structural Pre qualification criteria, then he can form a consortium with the other partner i.e. either civil & structural who is qualified for the same and the lead partner can bid for both civil and structural works based on MOU between them. Copy of the MOU shall be furnished along with the bid.
 - ii. In such case, average annual turnover of each partner in the preceding three (3) financial years as on the date of bid opening, shall be not less than Rs 50 Crores
 - iii. However BHEL will place order only on the lead partner.

REVISED PQ:

- a) Bidder should have designed, engineered and executed the following works within the preceding seven (7) years as on the date of bid opening:
 - I) Basement type structures like Track hoppers, Wagon Tipplers, Tunnels etc. involving deep excavation and extensive dewatering and industrial buildings with finishing works for minimum depth up to (-)12.0 m below ground level.
 - II) Minimum 13,000 cu.m. of reinforced cement concrete work in any one (1) year in a single contract or multiple contracts
 - III) Minimum 3500 MT of fabrication and erection of steel structures in a period of any one (1) year in a single contract or multiple contracts.
- b) Average annual turnover of the bidder, in the preceding three (3) financial years as on the date of bid opening, shall not be less than **Rs 75 crores.**

- c) i) In case, the bidder is not meeting either civil or structural Pre qualification criteria, then he can form a consortium with the other partner i.e. either civil & structural who is qualified for the same and the lead partner can bid for both civil and structural works based on MOU between them. Copy of the MOU shall be furnished along with the bid.
 - ii) In such case, average annual turnover of each partner in the preceding three (3) financial years as on the date of bid opening, shall be not less than **Rs 40 Crores**
 - iii) However BHEL will place order only on the lead partner.
 - iv) In addition to above, Bidder who has not designed civil and structural works but has executed systems involving underground structures like track hopper, wagon tippler, underground tunnels, etc. which meets the PQ etc as mentioned in clause a i), ii) and iii) above can also quote, provided the bidder ties up with a design agency who has designed structures like in the preceding 7 years. Name and credentials of the design agency shall be brought out clearly in the offer
