- Offer will be evaluated based on total price for Supply and Erection & commissioning (i.e. Sl. Nos. **A+B** of price format).
- For purpose of ordering of complete Air Conditioning System by BHEL, the charges for E&C (Erection, Commissioning, Trial Runs and Performance Testing of Complete Air conditioning system) shall be

minimum 15% of the Price for supply of main package (i.e. Sl. no. A of price bid format) excluding taxes and duties, failing which break up of prices shall be adjusted accordingly for evaluation & ordering.

i.e. Total Price for Erection & Commissioning (B) = **0.15 x (A1+A2+A3)**.

5. Separate Purchase Orders will be issued for Supply portion and for Erection & Commissioning works of this project. The Purchase Order for Supply portion will be issued by BHEL-PE&SD whereas the Purchase Order for E&C portion will be issued by BHEL-Site (BHEL's Construction Management Division).
6. During execution of contract, if there is any additions / deletions of items from the above scope of supply, the unit rate shall be applicable for the additions / deletions of items till the execution of the contract. The additions/deletions can be to the tune of + 10% and - 10% of order Value.
7. Bidder to quote the base rates only. All Applicable taxes and duties to be indicated separately for the Supply Portion and Erection & Commissioning Portion.
8. Bidder is required to furnish confirmation to this priced bid format in their technical offer by indicating 'Quoted' against all the items listed above, failing which their offer may be liable for rejection.
9. The Total Lumpsum price quoted shall be INCLUSIVE of Freight, Packing & Forwarding and Testing Charges.
10. The Total Lumpsum price quoted shall be EXCLUSIVE of GST, Third party inspection (TPI) & Insurance Charges.
