**Note :**

- 1) The Rate will be **fixed throughout the contract**.
- 2) For award of work, Lump sum L1 amount shall be considered , Order will be placed only to one party on the basis of the overall lowest quoted price in the bid. The work will not be split in any circumstances
- 3) The bidder should submit their quotation either on their letter head or by way of return of original tender document duly filled, signed & stamped.
- 4) The bidders must quote competitive prices competitive process considering the fact that price negotiations. If required to be held with the lowest tenderer only.
- 5) In case of Tie between two or more parties, discounted offer shall be asked from respective bidder and L1 will be decided on the discounted offers. Discounted Offer to be called in sealed bids and shall be opened in tender room ,if prices are still in tie ,the decision of L1 shall be on lottery basis.
- 6) Bid should be free from correction, overwriting, using correcting fluid etc. Any interlineation, cutting, eraser or overwriting shall be valid only if they are attested under full signature(s) of person(s) signing the bid as bid shall be liable of rejection.
- 7) All cuttings & corrections in the bid document should be avoided. In case the tenderer resorts to many corrections including usage of white correction fluid in the tender document, the tender shall be liable for rejection.
- 8) Discrepancy in Words & Figures:-
  - (a) If, in the price structure quoted for the required goods/ services/ works, there is discrepancy between the unit price and the total price (which is obtained by multiplying the unit price by the quantity), the unit price shall prevail and the total price corrected accordingly, unless in the opinion of the purchaser there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price corrected accordingly.
  - (b) If there is an error in a total corresponding to the addition or subtraction of subtotals , the subtotals shall prevail and the total shall be corrected; and
  - (c ) If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject of (a) and (b) above.
  - (d) If there is such discrepancy in an offer, the same shall be conveyed to the bidder with target date upto which the bidder has to send his acceptance on the above lines and if the bidder does not agree to the decision of the purchaser, the bid is liable to be ignored.
