If the Qualifying work is executed in the last seven years period, as specified above, even if it has been started earlier, the same will also be considered meeting the qualifying requirements.
6. ‘Successfully completed’ means the bidder should have achieved the criteria specified in the Technical criteria of PQR (as in ‘B’ above) even if the Contract has not been completed or closed. The bidders will be required to submit successful completion of work completed (completion of entire work with closing of contract or part successful completion certificate upto a minimum level specified in the criteria B above).
7. For PQR ‘B’ value of work is to be updated as per the PVC formula of GCC with Indices for “All India Avg. Consumer Price Index for Industrial Workers” with base month as date of execution and indexed up to two months prior to the bid opening month. This condition will be applicable only for the completed jobs and not for the jobs in progress as on date of technical bid opening.
