EXPRESSION OF INTEREST (EOI) FOR VEHICLE CONTRACT

BHEL – Piping Centre, T.Nagar, Chennai - 600017 hereby invites prospective and resourceful Bidders to submit their Expression of Interests (EOIs) w.r.t Contract for Supply of Vehicles on Casual and Monthly Hire Basis.

1.0 Scope of Work:

The Contractor shall Supply Vehicles on a Daily Basis / Monthly Basis to BHEL – Piping Centre, No.80/93, G.N.Road, T.Nagar, Chennai-600017.

2.0 Tenure of Contract:

24 (Twenty Four) Months

3.0 Value of Contract:

The Total Annual Contract Value for the above Scope of Work would be approximately ₹96.00 Lakhs (Rupees Ninety Six Lakhs only).

4.0 Pre-Qualification Criteria (PQC):

- 4.1 The Bidder must be a Registered Firm / Partnership Firm / Company with Minimum Experience of Three Years in this field.
- 4.2 The Bidder shall have a full-fledged Office Setup in Chennai with Landline Phone, Mobile Phone, Fax & Email Facilities, which shall be accessible round the clock (24x7). A prominent Display Board with Firm/Company Name at the Office Address in Chennai with Address and Phone Numbers, shall be placed.
- 4.3 The Bidder should have supplied vehicles to a minimum of Five Organizations (Private / Government / PSU).
- 4.4 The Bidder must have a minimum of own / attached Ten Vehicles (2012 & 2013 Models only), out of which Three must be High-End Vehicles (like Ford Fiesta / Swift Dezire / Honda City / Toyota Corolla / Toyota Etios / Toyota Innova / Chevrolet Tavera / Maruti SX4 / Maruti Ertiga / Mahindra Scorpio / Mahindra Bolero, etc or equivalent models).
- 4.5 All the own / attached Vehicles must be registered / attached only in Company / Firm / Partner / Proprietor Name, as applicable.
- 4.6 All the vehicles must be registered for commercial usage only (Tourist Vehicle Registration - "T" Board).
- 4.7 The Average Financial Turnover of the Bidder seeking EOI for a period of Two Financial Years ending 31.03.2012 shall be ₹1.5 Crores.
- 4.8 The Bidder shall be an Income Tax and Service Tax Assessee.

5.0 Documents to be Submitted as a Proof for Fulfilling the PQC:

- 5.1 A Copy of Registration Certificate of Firm / Partnership / Company.
- 5.2 A Clientele List comprising of Major Clients along with the copies of Work Order / LOI / Agreement Copy to whom the Bidder had provided or / and providing Similar Services.
- 5.3 Certified Copies of Acknowledged Income Tax Returns, Profits & Loss Account Statements and Balance Sheets for the last Two Financial Years i.e. Financial Year 2010-11 (Assessment Year 2011-12) and Financial Year 2011-12 (Assessment Year 2012-13).
- 5.4 Copy of PAN Card and Certificate of Service Tax Registration.
- 5.5 Bidder must submit a Declaration that they fulfill all the Pre-Qualification Criteria and also that no case is pending before the Police / Court against the Proprietor / Firm / Partner / Company, as well as the Bidder has not been blacklisted by any Organization.
- 5.6 Bidder shall also submit their EOIs for the proposed Contract in their Letter Heads specifying their Registered Office Address, Chennai Office Address indicating the approximate distance of the same from BHEL Piping Centre Office Location as specified above.
- 5.7 Copy of Registration Certificate of all the own / attached Vehicles shall be produced. In the event of attaching Vehicles, Agreement with the Bidder's Firm / Partnership Firm / Company, duly signed, shall be produced.
