**A) TRANSPORTATION:**

**Clause No. 1.71 of Section I of NIT is withdrawn and it is replaced with below Terms:**

Under exceptional circumstances, BHEL may request for diversion of jobs loaded for one project to another with the consent of vendor and appropriate approvals. In such cases, the differential freight cost from vendor location to designated project site and revised project site shall be paid as Extra / deducted from finalized rate, as applicable. The calculation of freight cost shall be as per BHEL's Centralized Transport Contract 2024-26.

**Rates shall be calculated based on below rate schedules derived from our Central Transport Contract.**

S No	Description	Rs per Km per MT Excluding GST
1	Anywhere to Anywhere in India – Up to 200 Km	5.80
2	Anywhere to Anywhere in India – Above 200 Km and up to 500 Km	3.88
3	Anywhere to Anywhere in India – Above 500 Km	3.11

**For Eg 1:**

If a PO is placed for Mirzapur project (under Rate schedule identified for Mirzapur project) on Vendor A and if the job is to be diverted for Kawai project under exceptional circumstances, then the following calculations will be done.

Distance from Vendor A to Mirzapur = 200 Km (x)

Distance from Vendor A to Kawai = 750 Km (y)

Freight for Vendor A to Mirzapur as per above table and slab =  $200 * 5.80 = \text{Rs. } 1160 \text{ per MT}$

Freight for Vendor A to Kawai as per above table and slab =  $750 * 3.11 = \text{Rs. } 2332.5 \text{ per MT}$

Extra freight to be paid to vendor per MT =  $2332.5 - 1160 = \text{Rs. } 1172.5 \text{ per MT}$

In above example, this extra freight payable to vendor shall be informed to vendor and consent shall be obtained before proceeding with approval for diversion of PO from one project to another.

**For Eg 2:**

If a PO is placed for Mirzapur project (under Rate schedule identified for Mirzapur project) on Vendor A and if the job is to be diverted for Korba project under exceptional circumstances, then the following calculations will be done.

Distance from Vendor A to Mirzapur = 1200 Km (x)

Distance from Vendor A to Korba = 750 Km (y)

As both project locations fall under third slab above 500 Km, the differential distance shall be calculated and applicable slab rates shall be applied for payment / deduction.

The differential distance between two projects from vendor location shall be difference of x and y = 450 km.

Freight for the differential distance shall be calculated as per above table

Distance: 450 Km

Rate per Km per MT (As per Slab of both the projects): Rs. 3.11

Applicable deduction per MT =  $450 * 3.11 = \text{Rs. } 1399.5$  per MT

Similarly, in case of deduction of Freight charges, shall be informed to vendor and consent shall be obtained before proceeding with approval for diversion of PO from one project to another."

**B) CONFLICT OF INTEREST:**

**Clause No. 41 of Section I of NIT is withdrawn and it is replaced with below Terms:**

**TREATMENT OF CASES REGARDING CONFLICT OF INTEREST:**

The bidder notes that a conflict of interest would said to have occurred in the tender process and execution of the resultant contract, in case of any of the following situations:

- i. If its personnel have a close personal, financial, or business relationship with any personnel of BHEL who are directly or indirectly related to the procurement or execution process of the contract, which can affect the decision of BHEL directly or indirectly;
- ii. The bidder (or his allied firm) provided services for the need assessment/ procurement planning of the Tender process in which it is participating;
- iii. Procurement of goods directly from the manufacturers/ suppliers shall be preferred. However, if the OEM/ Principal insists on engaging the services of an agent, such agent shall not be allowed to represent more than one manufacturer/ supplier in the same tender. Moreover, either the agent could bid on behalf of the manufacturer/ supplier or the manufacturer/ supplier could bid directly but not both. In case bids are received from both the manufacturer/ supplier and the agent, bid received from the agent shall be ignored. However, this shall not debar more than one Authorised distributor (with/ or without the OEM) from quoting equipment manufactured by an Original Equipment Manufacturer (OEM) in procurements under a Proprietary Article Certificate.
- iv. A bidder participates in more than one bid in this tender process. Participation in any capacity by a Bidder (including the participation of a Bidder as a partner/ JV member or sub-contractor in another bid or vice-versa) in more than one bid shall result in the disqualification of all bids in which he is a party. However, this does not limit the participation of an entity as a sub-contractor in more than one bid if he is not bidding independently in his own name or as a member of a JV.
