SI No	BHEL Technical & Commercial Terms and Conditions for Indigenous Vendors	Vendor's Confirmation
1	Vendor should give confirmation to BHEL's Technical Specification. Any deviations from the specification are to be furnished separately as "Schedule of Deviation". If there is no deviation vendor should indicate "No Deviation".	
2	The vendor shall provide necessary drawings, Test Certificates/Chemical composition certificate and Operating Maintenance Manuals as called for in the Technical Specification, in the required number of copies at no extra cost. Specific Make / Brand of the item if any shall be indicated clearly in the offer	
3	Guarantee / Warranty certificate to be provided wherever applicable. Replacement during warranty period shall be supplied free of charge on FOR SSTP BHEL basis. The supplied item shall be guaranteed for 12 months from the date of material acceptance. In case of any failure or trouble reported, the supplier shall replace the item free of cost	
4	Vendor to indicate Quoted/Not Quoted item wise in Technical bid (Part I)	
5	Prices shall be quoted item wise only in the Price bid (Part II).	
6	In case of Dealer, Authorization certificate from Principal supplier is required	
7	Prices shall be quoted on " Firm Price " basis only. The prices should be only on FOR SSTP/Stores, BHEL, Trichy -14 basis , inclusive of taxes, Packing & Forwarding, Freight & Insurance / other charges if any. Complete break-up of the quoted price in the required price bid format shall be furnished by the Bidder. However, evaluation of the bid shall be on the basis of total all inclusive, landed price at consignee destination (unless otherwise specified in the ATC).	
8	Validity of offer shall be 90 days from the date of Tender opening.	
9	Delivery period shall be within 2 Months from the date of Purchase order. All items shall be properly packed to avoid any transit damages.	
10	Liquidated damages @ 0.5% per week subject to a maximum of 10% of the order value of delayed quantity shall be applicable for delay in deliveries. If you are not accepting BHEL LD terms, your offer will be liable for rejection..	
11	Following Risk Purchase clause shall be applicable: The Purchaser at his option will be entitled to terminate the contract and to purchase elsewhere at the risk and cost of the seller either the whole of the goods or any part which the supplier has failed to deliver or dispatch within the time stipulated or if the same were not available, the best and the nearest available substitute therefore. The supplier shall be liable for any loss which the Purchaser may sustain by reason of such risk purchases.	
12	Payment terms - 100% direct EFT Payment within 60 days of acceptance of material. In case the vendor comes under MSE category, 100% direct EFT Payment within 45 days of acceptance of material, for which tenderer has to furnish valid MSE certificate.	
13	GST No, applicable GST % along with HSN code should be mentioned in the offer and the GST benefit (If any) shall be passed on to BHEL.
