Pre-qualification criteria (PQR):

1	Only manufacturers can submit quotations, dealers are not permitted.
2	Bidder should offer Cast Iron Blade as per BHEL Drawing and as per specification TFN NO. 367 GGG40 Rev.0 without any deviation.
3	Bidder should have supplied similar size/type of Cast Iron Blades for 210MW and above rating thermal power station.
4	Supplied Blades should be in continuous operation for at least One year as on the date of technical bid opening.
5	Bidder to provide full technical details and years of operation of supplied blades
6	Bidder to submit credentials of client i.e. customer name, contact person, phone No., email etc. as a part of reference along with the offer.
7	Bidder have to submit Purchase Order copy and commissioning report to substantiate the supply of blades.
8	Supplier have to submit Copy of Annual Report/Statement of Profit and Loss Account certified by Chartered Accountants together with a certified copy of audited Balance Sheet.
