1	Only manufacturers can submit quotations, dealers are not permitted.	
2	Bidder should offer Cast Iron Blade as per BHEL Drawing and as per specification TFN NO. 367 GGG40 Rev.0 without any deviation.	
3	Bidder should have supplied similar size/type of Cast Iron Blades for Axial Fan of 210MW and above rating thermal power station.	
4	Supplied Blades should be in continuous operation for at least One year as on the date of technical bid opening. This is applicable for vendors who are not registered with BHEL for this item.	
5	Bidder to provide full technical details and years of operation of supplied blades	
6	Bidder to submit credentials of client i.e. customer name, contact person, phone No., email etc. as a part of reference along with the offer.	
7	Bidder have to submit Purchase Order copy and commissioning report to substantiate the supply of Blades.
