1. Facilities Required and Qualification Criteria

- a) 5-Axis machining centre Min. table size dia. 500 mm.
- b) 3D CMM Table to accommodate impeller of dia. up to 500 mm. Inspection probe to reach the entire depth of the vane. (A Tie up with reputed vendor with 3D CMM facility also may be accepted. Necessary Documentation is to be provided in this case.)
- c) For Technical Qualification in this tender, the interested vendors have to do scoop milling in one mock up piece with their own material, on their own machine, at their works. The last date for proving the mock-up is 15 days from the due date of tender opening. However, the date may be extended only at the discretion of BHEL.

- f) The machining of the mock up has to be taken up as per the model sent by BHEL. Three pockets have to be machined in one full circular disc. The machined mock-up has to be offered for inspection to BHEL OC on 3D CMM.
- g) Payment will not be made for proving the mock-up and the material need not be sent to BHEL after prove out.
- h) Vendors, who have already proven their capability for scoop milling on the mock-up piece as per BHEL requirement in the earlier enquiries, need not do mock up machining again and will be considered as technically qualified for this tender.
