SCOPE

This standard covers the requirement of canvas gloves

COMPLIANCE WITH STANDARDS

Have uniform thickness as per Is: 1424 – 1983; Clute pattern as per IS : 6994 (Part-1) – 1973; size as per IS 2573; thread as per IS 1720.

- Authenticated photo copies of the latest test certificates (from OEMs, National Accredited Test Laboratories) to be submitted along with the offer.
- Vendor/bidder to furnish authorization letter from Principal/OEM against the enquiry quoted.
- Vendor/bidder to submit along with the offer, authenticated copy of latest certificate of product conformity to relevant IS/EN/ANSI standards.
- For each PPE specification, the Vendor/Bidder shall confirm their acceptance to the BHEL specifications by Signing and Stamping on it.

TECHNICAL REQUIREMENT

- They shall be made out of good quality, thick canvas cloth
- They shall be Five Fingers type clute pattern as per IS
- The stitches shall be 2.5 mm with the end of all stitching securely back stitched.
- The cotton sewing thread conforming to Variety No. 23 shall be used.
- The size shall be 14” and shall give protection against dirt, dust, oil, grease etc.
