Competent authority also accorded their approval for the same vide note # 25.

Till the evening of 04-08-2022, no response has been received in tender box against the said enquiry. Due to cited lackluster response, it is proposed to extend the bid submission time by another 11 days i.e. till 15:30 Hrs of 16-08-2022.
