1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Scope of Supply

Scope of supply (Bid price to include all cost components): Only supply of Goods

3. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

4. Generic

- 1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- 2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
- 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

5. Generic

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

- i) The Seller fails to comply with any material term of the Contract.
- ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

Pre-Qualification Criteria (PQC):

Bidder should have supplied same or similar item (EN series steel material) against any customer purchas e order/job work order of any value. Relevant purchase order(s) along with Invoice(s) shall be enclosed to fulfil this experience criteria. The purchase order/s should co-relate to its submitted invoice/s. All mentione d values are net of taxes. Purchase Order(s) date & corresponding invoice(s) date should be from 01.06.20 22 onwards till bid opening date.

Start-ups shall be exempted from this criteria without any relaxation in quali ty standards or technical parameters as per D.O. No. 5(4)/2016-BE-I dated 15.0 2.2017. For claiming Start-Up exemption, vendors have to submit DPIIT (Dept. o f Promotion of Industry and Internal Trade)/DIPP (Department for Industrial Polic y and Promotion) recognition certificates.

Payment Terms: Payments shall be made to the Seller within the mentioned days (as per below ta ble) of material entry date at BHEL IVP and on-line submission of bills. In case there is shortfall in documen ts/deficiency in material as per the tender terms/purchase orders the same shall be notified by BHEL to su pplier within 15 days. To be considered as Micro, Small or Medium enterprise, bidder must be manufa cturer of offer product and relevant valid certificate as per latest MSME guidelin es is to be submitted along with bid. In case of bid submitted as trader / dealer etc., bidder will be considered as Non-MSME.

Breach of contract. Remedies and Termination

In case of breach of contract, wherever the value of security instruments like pe rformance bank guarantee available with BHEL against the said contract is 10% of the contract value or more, such security instruments to the extent of 10% c ontract value will be encashed. In case the value of the security instruments av ailable is less than 10% of the contract value, the balance amount be recovered in all or any of the following manners:

- from dues available in the form of Bills payable to defaulted supplier against the same contract.
- from the dues payable to defaulted supplier against other contracts in the sa me Region/Unit /any other region/unit.
- In-case recoveries are not possible with any of the above available options, Le gal action shall be initiated for recovery against defaulted supplier.

Further, levy of liquidated damages, debarment, termination, de-scoping, short closure, etc., shall be applied as per provisions of the contract.

Warrantee and Corresponding Repair / Replacement of Goods

Goods shall comply with the specifications for material, workmanship and performan ce. Unless otherwise specified, vendor shall give a warrantee against design & manuf acturing defects for a period of 18 months from the date of receipt. In case of non-ac ceptance of this term, bid shall be liable for rejection.

Treatment of cases regarding conflict of interest:

The bidder notes that a conflict of interest would said to have occurred in the tender process and execution of the resultant contract, in case of any of the following situations:

- i) If its personnel have a close personal, financial, or business relationship with any personn el of BHEL who are directly or indirectly related to the procurement or execution process of the contract, which can affect the decision of BHEL directly or indirectly.
- ii) The bidder (or his allied firm) provided services for the need assessment/ procurement pla nning of the Tender process in which it is participating.
- iii) Procurement of goods directly from the manufacturers/ suppliers shall be preferred. Howev er, if the OEM/ Principal insists on engaging the services of an agent, such agent shall no t be allowed to represent more than one manufacturer/ supplier in the same tender. Mor eover, either the agent could bid on behalf of the manufacturer/ supplier or the manufact urer/ supplier could bid directly but not both. In case bids are received from both the ma nufacturer/ supplier and the agent, bid received from the agent shall be ignored. Howeve r, this shall not debar more than one Authorized distributor (with/ or without the OEM). fr om quoting equipment manufactured by an Original Equipment Manufacturer (OEM) in p rocurements under a Proprietary Article Certificate.
- iV) A bidder participates in more than one bid in this tender process. Participation in any capa city by a Bidder (including the participation of a Bidder as a partner/ JV member or sub-c ontractor in another bid or vice-versa) in more than one bid shall result in the disqualific ation of all bids in which he is a party. However, this does not limit the participation of an entity as a sub-contractor in more than one bid if he is not bidding independently in his o wn name or as a member of a JV.

The Bidder declares that they have read and understood the above aspects, and the bidder confirms that s uch conflict of interest does not exist and undertakes that they will not enter into any illegal or undisclose d agreement or understanding, whether formal or informal with other Bidder{s}, in this regard. This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to introduce cartelization in the bidding process. n case, the Bidder is found having indulged in above activities, the same will be considered as a violation of the tender conditions, and suitable action shall be taken by BHEL as per extant policies/ guidelines.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
