Sealed Tenders are invited by the Estate Officer for Licensing of shop premise in Mobile Phone and Electrical Goods Sales & Service trade situated at Shopping Complex of the company's township as detailed below subject to the terms and conditions of Allotment Rules of Bharat Heavy Electricals Limited, Ranipet- 632 406.

1.DETAILS AS FOLLOWS

- Place : Shop Number- 3, BHEL Shopping Complex, BHEL Township, Ranipet- 632 406, Tamil Nadu
- Type of Space : Built up area covered with roof Measuring 18.24 Square Meter (4.8 meter length x 3.8 meter breadth)
- License Fee : License Fee shall be fixed by Tender. Minimum Reserve License Fee is Rs.50/- per square meter per month (Rs. 50 x 18.24 Sq.mt.= Rs. 912/- per month) and final License Fee shall be fixed based on valid bids. License Fee together with allied charges (Service Tax, Cess, Electricity Charges & Water Charge, wherever applicable) shall be payable on or before 5th of every month.
- Service Tax : Service tax @ 12 % or at the applicable rates payable on the License fees to be borne by the occupant.
- Cess : Cess @ 3% payable on the Service Tax amount at present. Any increase will have to be borne by the occupant.
- EB charges : EB charges have to be borne by the successful tenderer and should remit of their own as per meter reading. EB deposit also to be borne by the successful tenderer. Any increase rate proposed by TNEB, will have to be borne by the occupant.
- Period of allotment : 5 years from the date of allotment. Renewal after 5 years may be considered at revised terms and conditions agreeable to both the parties.

2.ELIGIBILITY CREITERIA

- a. Experience in professionally running Mobile Phone and Electrical Goods Sales & Service shop for minimum period of Three years between 01-04-2005 and 31-03-2013.
- b. Average Annual Turnover during the last three years shall be atleast Rs. 5 Lakhs.

3.TERMS & CONDITIONS

3.1. Earnest Money Deposit:

Each Tender must be submitted together with a Demand Draft for Rs.11,000/- (Rupees Eleven thousand only) drawn on any Nationalised Bank in favour of "Bharat Heavy Electricals Limited, Ranipet- 632 406" payable at SBI, Mukundarapuram (Branch Code 7013) towards Earnest Money Deposit (EMD). Tenders received without Earnest Money Deposit shall be summarily rejected. Cheques will not be accepted.

Earnest money deposit of unsuccessful tenderers shall be refunded after expiry of validity period of the tender. In the case of successful tenderer, earnest money deposit will be adjusted towards the Security Deposit or it may be forfeited in case the successful tenderer refuses to accept the award of License or fails to complete the required formalities and occupy the premises within the specified and permitted time and delay in starting the actual operation beyond the permitted time under the License.

3.2. Security Deposit:

Successful bidder shall have to deposit an amount which is equal to the six months License fee as Interest free Security deposit and the same will be returned without interest after the License period is over and after surrender of the building by the occupant subject to full settlement of dues payable to company.

- 3.3. Selection of successful Bidder shall be made by BHEL, Ranipet. The successful bidder will be selected, based on the highest rate of License Fee offered and on the basis of his experience in the business, performance, reputation etc. in the relevant field. The decision of the Tender Committee shall be final in this regard.
- 3.4. Tenderer, in his own interest, should inspect the proposed premises / place before submitting tender.
- 3.5. The successful tender shall have necessary license as required by Govt. authorities / statutory authorities for running the shop.
- 3.6. The tender application, complete in all respects to be submitted in a sealed cover with inscription on the top left side "Tender for Shop No. 3 for Mobile Phone and Electrical Goods Sales & Service" and drop it in the sealed tender box placed in the office of Estate Officer by the stipulated date and time. The management shall not be responsible for any loss or delay in receipt of the tender by post.
- 3.7. Successful Tenderer shall complete all formalities within 15 days time including deposit of security deposit and execution of License Deed prescribed by BHEL and shall start his business within 60 days from the date of allotment of building.

- 3.8. Tenderer should declare about the employment of any terminated/dismissed employee of BHEL/Government/Govt. Organizations.
- 3.9. The shop premises allotted shall be utilized for running the specified business / trade only and shall not be used for any other purpose/business.
- 3.10. Shops shall be run effectively and shall not be closed except on weekly holidays / public holidays.
- 3.11. The period of License will be for five years and renewable at the option of BHEL based on the performance.
- 3.12. Compliance with the various statutory requirements, norms and rules and regulations prescribed will be the responsibility of the licensees including the financial implications thereof. The successful tenderer, before the commencement of business, shall obtain all licenses such as Trade License, Eating House License and all ancillary licenses/permissions/clearances that may be required to be obtained by the Licensee from any authority/authorities at their own cost for the operation of the outlet. The successful tenderer shall solely be responsible to ensure and keep such Licenses valid throughout the license period.
- 3.13. The successful tenderer or his employees shall maintain harmony in the township and shall not indulge in any illegal activities in the Township premises. In case of any such event/ activities detrimental to Company's interest / decency / morality etc, the company shall have the right to terminate the agreement on one week's notice.
- 3.14. All taxes and Government levies as applicable from time to time like, entertainment tax, sales tax, cess etc. if any, will be payable over and above the amount of license fee.
- 3.15. The tenderer will take comprehensive insurance to cover all type of damages to the property and casual / walk-in guests, his staff, stocks, stores, spares, equipments etc.
- 3.16. Model License Deed will be provided by BHEL for execution to the successful tenderer on allotment. License Deed to be furnished in Non Judicial Stamp Paper of Rs.100/- by the licensee.
- 3.17. Tender documents consisting of Pre-Qualification Bid (Part 'A') & Commercial Bid (Part-'B') are to be duly sealed in two separate inner covers. The two inner covers should be sealed outer cover super scribing as "Tender for Allotment of Shop-3.
