- c. The behaviour of bidder at the place of work shall be polite, should have good temperament. The contractor should be responsible for observance of all regulations by the staff employed by him. Courtesy and good behaviour on the part of the workers is important Discourteous and and/or careless workers should be replaced.
- d. The bidder shall ensure that no damage is caused by his workmen during working hours to any person, property of other parties (working hours at the place of work). If any such damage is caused, it is the responsibility of the contractor to make good the losses or to compensate for the same.
- e. In case the bidder is required to undertake any work outside the scope of this contract, the rates payable shall be those mutually agreed upon.
- f. All safety rules and codes applied by BHEL at the place of work shall be observed by the contractor without exception. The contractor shall be responsible for the safety of the workers, T&Ps etc. and work to be performed by him and shall maintain all protection necessary for the purpose. The contractor shall also take precautions as may be indicated from time to time by BHEL with a view to prevent pilferage, accidents, fire hazards etc. and due precaution shall be taken against fore seen or unseen hazards and atmospheric conditions.
- g. The bidder shall be responsible to arrange Gate Pass of workers, tools & plants and its timely renewal.
- h. While on duty workers and operators should keep with them the proper gate passes, records of the vehicle, and valid driving license etc. for Inspection by official.
- i. The bidder shall be directly responsible for payment of wages to his worker(s)/ employees engaged by them by 10<sup>th</sup> of the following month. If there is any delay in submission & settlement of bill due to any reason


