

TECHNICAL CONDITIONS OF CONTRACT (TCC)

These Technical Conditions shall be read and construed along with General Conditions of Contract and in case of any conflict or inconsistency between the General & Technical Conditions of Contract; the content in this specification shall prevail.

1.0. SCOPE OF WORK:

- a) Following works are to be carried out by successful bidder under scope of this contract at Unit 5, 1X660 MW Sagardighi TPP:
 - Cleaning of surface of existing erected steel structures and handrails with buffing wheel / wire brush / cotton / thinner etc. as required and applying one coat of red oxide zinc-chromate primer of DFT 25 micron and one coat of synthetic enamel paint with minimum 25 micron dry film thickness (DFT) of approved make and shade to achieve an even shade over steel sections.
 - Scope also includes supply of Red Oxide Zinc-Chromate primer and Synthetic Enamel Paint (smoke grey).
