Please find below queries. Kindly share your comments. We are planning to depute our engineer to the site on 12th or 13th May 2023. Kindly share the site in-charge contact details and for the gate pass. Will share the visiting person contact details to you on 11th May 2023

1. Plant commissioned date
2. Power generation (Y-O-Y) details from the date of commissioning to till date
3. DC capacity of 40MW and 25MW
4. Machine breakdown details
5. Maintenance of transmission (evacuation) line is under whose scope. If yes, mode transmission. Is it overhead or underground
6. Hope Govt of Karnataka issued electrical license is enough (we have class I which is up to 33 KV) for this tender.
7. Payment – whether we have to follow “Central wages” or “state wages -Tamil Nadu”
8. Hope EMD is exempted for MSME (small) registered companies.
9. Hope RXIL (TReDS) facility is available for this service contract every month. Kindly confirm
10. Request BHEL to allow our engineer (min of 4 days) for complete survey. Hope all punch points (open points) shall be closed by BHEL before taking over the plant.
