2. Bidder to give single % of freight charges in the freight column mandatorily.

Bid should be complete in all respect for the full scope defined and considering all terms and conditions agreed.

4. Bidder to note that total price indicated above at C shall be considered for evaluation and hence should be complete in all respect for the full scope defined and considering all terms and conditions agreed.

5. Delivery schedule of Lot-I and subsequent lots shall be as per NIT.

6. For any clarification please refer Technical Specifications.

7. The quantities, which are indicated above shall be released for manufacture & supply as per NIT.

8. Manufacturing of above quantities shall be done after the approval of technical & quality documentation, and supply of the same shall be completed as per NIT.

9. The total quantity variation shall be limited to +30% of the total contract value derived on the basis of the ordered quantities.

10. Subsequent lot shall be cleared for manufacture based on project requirement. Delivery completion of supply of each lot from the date of clearance of the quantities shall be as per NIT.

11. The unit price quoted by bidder shall be binding for quantity variation (as per sl. No.9 above) which is at discretion of purchaser.

12. Design engineering charges are considered to be included in main equipment supply price. No separate charges shall be applicable.

13. Prices shall remain firm during contract execution.
