Supplier should demonstrate the performance of the Equipment and all its accessories to ensure compliance with complete specifications & parameters quoted by them to the satisfaction of BHEL/end user. Training to chemists at site during installation should be provided for routine maintenance, operation and safety purpose. Failing to comply to the Installation and Commissioning clause, the offer will be rejected straightaway.

**Warranty:** The equipment shall be warranted for satisfactory performance for a period of 18 months from the date of installation or 24 months from date of dispatch, whichever is later. Failing to comply to the warranty clause, the offer will be rejected straightaway.

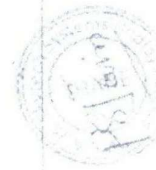
